How to count international signatures

If a Lithuanian Business plan user invites a Belgian citizen to sign a document, the total cost of signing the document for the initiator will be 2.10 EUR (0.30 EUR for Lithuanian signature + 1.80 EUR for Belgian signature).

If the same person additionally adds a Norwegian citizen who signs with BankID, 10 NOK will be added to the total price; the currency will be converted to EUR at the exchange rate of the previous day the invoice is issued. Let's say 1 NOK = 0.0863488 EUR, so the Norwegian signature will cost 0.86 EUR, therefore, 2.10 EUR + 0.86 EUR = 2.96 EUR.

* – [eIDAS](#) defines 3 levels of signatures:

Qualified Electronic Signatures (QES) – they have the same legal effect as handwritten signatures and cannot be questioned in court.

Advanced Electronic Signatures (AdES) – they link data to the signatory and ensure the integrity of the document. Advanced Electronic Signatures based on a Qualified Certificate (AdES/QC) are considered strong evidence in court. At Dokobit, AdES are created by collecting the evidence that the person has consented to sign the document with a chosen eID and adding an e-seal on that document to confirm their consent. Simple Electronic Signatures (SES) – they are the most basic electronic signatures that do not require strong signer authentication. At Dokobit, SES are created by collecting the evidence that the person has consented to sign the document with an SMS one-time password and adding an e-seal on that document to confirm their consent.
