On the field, our teams delivered outstanding performances across all divisions. Congratulations to our AAL3 and AAM11 teams, who were crowned Champions, and to our AAM12 Blue side, who finished as Premiers after an excellent season. Our AAM12 Red, AAM3, AAM4, AAL2, 14/1, 12/1, and 12/5 teams also reached the semi-finals, showcasing the depth of talent and dedication across the club.

A highlight of the season was being named the Hills Club Championship Winners — a testament to the collective effort of all our players, coaches, and volunteers who represent North Rocks with pride every week.

Off the field, our sense of community remains at the heart of everything we do. From junior development to social events, the enthusiasm and support from families, coaches, and committee members continue to make our club a welcoming and vibrant place for everyone.

## 6. TREASURER'S REPORT

## 2025 Treasurer Report (01 October 2024 to 30 September 2025)

Note - To be read in conjunction with Annexure D - North Rocks Soccer Club Incorporated - 2025 Year End Financials

In our 60<sup>th</sup> anniversary year, 2025 was a year of reset with the focus being on setting the Club up financially so it can operate sustainably each year. I am pleased to inform all members that this has been achieved, and it was achieved by the hard work of many committee members past and present. The Club has no outstanding or accrued liabilities, sufficient cash flow, and has set up an appropriate balance between base income (player registrations) and costs to operate the season. This is critical for a Club of our size, this now allows for the right committee to take the club forward and be focussed on growth and continually improving the services we provide to our members and the community. With the day-to-day operations of the Club financially stable, the focus can be on grants, sponsorships, and other sources of income to match our strategic agenda and growth opportunities.

A few notable changes in the structure of the Club's financials:

 In 2025, Football NSW and other associations changed the way registration income was dispersed. Prior to 2025, each club collected the full registration amount from each registered player and then was responsible for dispersing the funds to others (Hills Association, Football NSW, Insurance etc). The registration process has been improved, when a player pays their registration fees, the funds are dispersed appropriately to each party, thus removing the need for significant levels of invoicing and accounting between associated parties. In this transition year it will distort any year-on-year comparisons on registration income and association fees in our accounts. To assist those who would like to know the financial performance of the Clubs registrations for 2025, the net registration income for 2025 was \$103,901.57, which is 15.8% (\$16,424.50) increase from 2024.

- With the changes to apparel supplier arrangements made in early 2024, our players and members now buy their club merchandise direct from Valour. This reduces the amount of stock the club is required to pre purchase and significantly improves the cash flow position for the club. It does however mean that when reviewing the clubs balance sheet, the assets held by the club will reduce significantly over time.
- To effectively prepare annual budgets, it was a requirement to review and categorise many of the clubs' larger expenses differently than previous years.
   Whilst the overall expense position remains the same, caution should be applied when completing year-on year comparisons for the higher expense lines such as presentations, trophies, meetings, events and ground hire.

#### 2025 Financial Performance

- Net Earnings: \$1,266.54 for FY25, down \$10,152.21 on FY24.
- Note on Net Earnings: As a committee we took the decision to invest further into the club's future with the proposed amendments to our constitution and organisational construct. The total investment for this review is forecasted to be \$15,429.00 plus implementation costs. FY25 financial position includes payment of \$12,142.90 of this cost. Adjusting for this strategic investment, net earnings on a like for like comparison would be \$13,409.44, up 17%. It is the Treasurers view that the committee should be commended for taking this decision and managing expenses throughout FY25 to fund this important investment into the club's future within this years operating budget.
- Gross Profit: \$126,958.45. Primary drivers of income and profit growth is registration income and net proceeds from canteen operations.
- Expenses: \$125,691.92. Expenses were well managed considering some significant growth in costs for club activities relating to ground hire and maintenance.

#### **Looking Ahead**

 To further support the strategic agenda of the Club, a significant upgrade in account practices and the clubs overall operating system is required. The investment in these capabilities will be modest and supported primarily on a volunteer basis; however, they have been put on hold until the outcome of the motions for the clubs operating name and constitution has been agreed. Planning has been completed to make these transitions in March 2026 and will see the club move to a more efficient, transparent, and strategic way of operating. Importantly, the new operating system will allow the club to embrace new technologies and provide much needed protection from frauds and scams and allow for a smoother transition with changes to committee membership.

- The Club is now entering grant submissions via NSW Office of Sport and local Club Grants (Pubs and Clubs) wherever we are eligible.
- To further grow the services we provide our members and the community, we require more sponsorship. In 2025 our new sponsorships were limited or inked to the clubs 60<sup>th</sup> anniversary celebration only. Large focus for our committee at an ongoing basis is to look for more partnership arrangements and sponsorship opportunities. Our sponsorship subcommittee will be soon ready to publish our revamped sponsorship packages that will be on offer from early 2026. I would encourage any member who can assist or know a local business who would like to be involved in our club to please reach out to the Club President or Club Treasurer.

I would like to add my sincere thanks to Belle Property for their continued support. Their 5-year sponsorship arrangement with our Club is extremely valued and providing direct benefit to each one of our members. It is greatly appreciated. Thank you also to our other sponsors, and those who assisted with our 60<sup>th</sup> Anniversary fund raising efforts.
