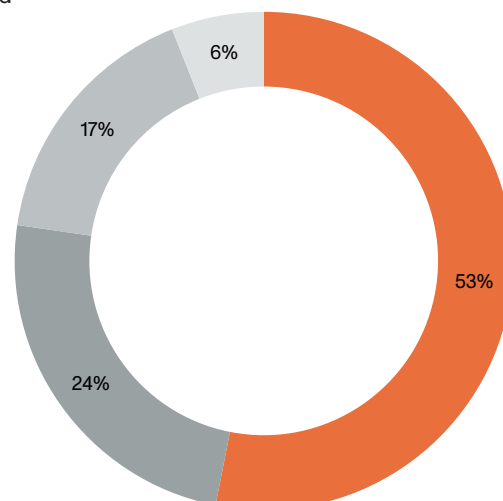

Portfolio revenue exposure

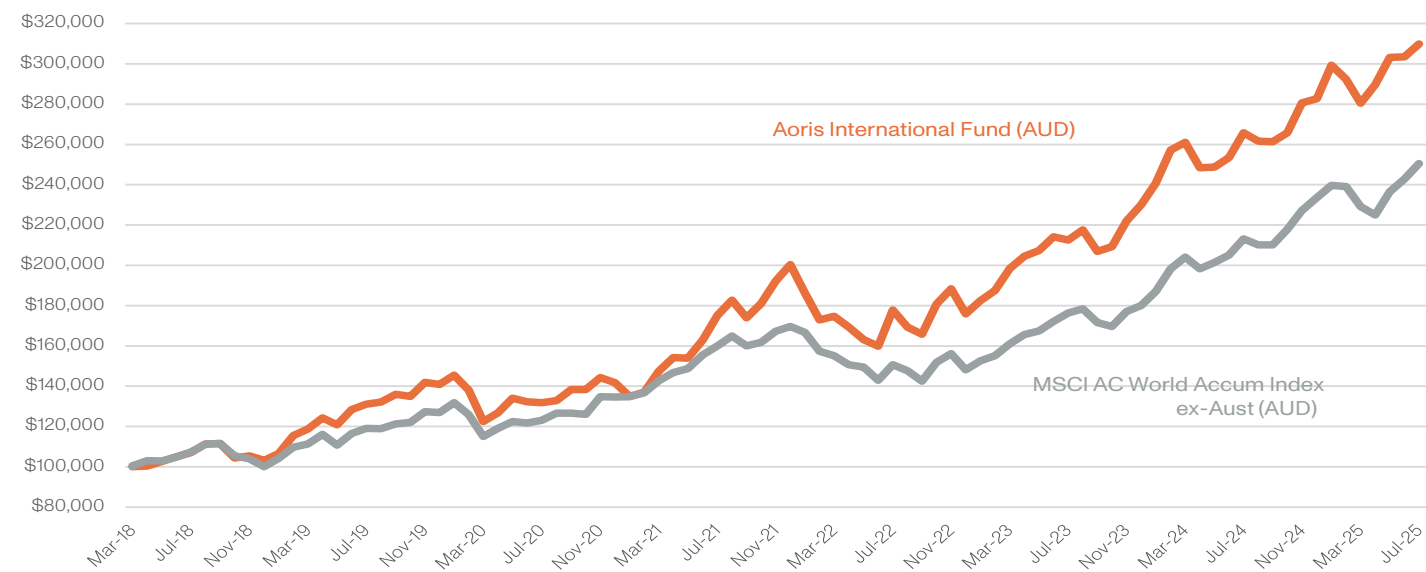
