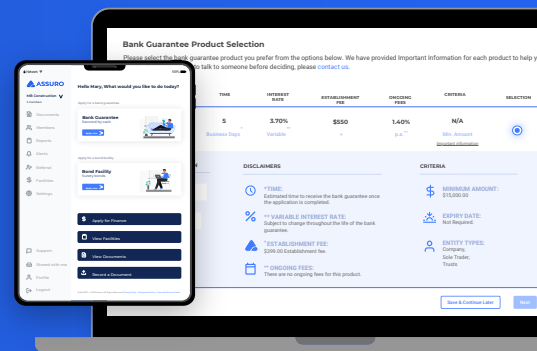

Assuro's application process

Complete your application online in minutes with bank guarantees finalised by the bank within days following the application process outlined below.

- 1 Register & Apply**
Create an Assuro account and follow the prompts to start your bank guarantee application.
- 2 Payment & Verification**
Complete payment of the fees and the verification process.
- 3 Submit to the Bank**
Once verified, your Assuro relationship manager will submit the application on your behalf.
- 4 Draft Bank Guarantee**
Once submitted, the bank will send a draft bank guarantee via email for approval and subject to its verification process.
- 5 Finalisation & Dispatch**
The cash security is deposited with the bank, the guarantee is then sent to the delivery address.

What you'll need

When you start the application process, you will need the following information:

- ▶ Bank guarantee value, purpose and description
- ▶ The applicant's details
- ▶ The beneficiary's details
- ▶ Two forms of ID for each applicant and any director of the applicant company. Individuals are verified using GreenID.

Frequently asked questions

DO I NEED TO COMPLETE ANY PAPERWORK?

No, the application process is entirely digital, though some physical documents may be required for identity verification.

IS THE BANK GUARANTEE PAPER OR DIGITAL?

The bank guarantee is issued on paper and sent by registered post to the nominated delivery address. Only the application process is digital.

WHO ISSUES THE BANK GUARANTEE?

The bank guarantee issued will be from the nominated bank and with the bank's logo on the guarantee. Assuro will not feature on the guarantee itself in any way.

HOW LONG DOES IT TAKE?

Applications can be submitted online in minutes, and the bank guarantee can be finalised and dispatched within days.

ARE ASSURO PRODUCTS ONLY SECURED BY CASH?

Assuro offers both cash-secured and partially secured bank guarantee products.

Our cash-backed guarantees are 100% cash secured, with no minimum value. Under the Financial Claims Scheme (FCS), deposits up to \$250,000 are protected by the Australian Government's guarantee on deposits.

Assuro's **Business Loan Bank Guarantee** option combines the guarantee with finance to secure it, allowing you to obtain the guarantee without providing the cash deposit upfront.
