

Co-Elite, Inc. Copyright Policy

At Co-Elite Inc., we respect the intellectual property rights of others and encourage all users to do the same. We maintain a policy of removing submissions that infringe on these rights, suspending access to our services for users who violate intellectual property laws, and terminating the accounts of users who repeatedly infringe on such rights.

Legal Framework

Co-Elite Inc. operates in compliance with the Canadian Copyright Act, specifically sections 41.25 and 41.26 (the "Notice and Notice" regime), and applicable intellectual property laws.

Submitting a Notice of Claimed Copyright Infringement

If you believe that your copyright or other intellectual property rights have been violated by a user of our services, please send a written notice to our designated Copyright Agent:

To ensure a prompt response, your written notice must include the following:

1. Your physical or electronic signature.
2. Identification of the copyrighted work or other intellectual property claimed to be infringed.
3. A precise identification of the allegedly infringing material to allow us to locate it (such as the URL where it appears).
4. Adequate contact information for you, including postal address, phone number, and email address.
5. A statement affirming your good faith belief that the use of the copyrighted material is not authorized by the owner or the law.
6. A statement confirming that the information in your notice is accurate.
7. A statement, under penalty of perjury, that you are authorized to act on behalf of the copyright or intellectual property owner.

Please note that in accordance with section 41.25(2) of the Canadian Copyright Act, notices **must not** include:

- Offers to settle the claimed infringement
- Demands for payment
- Requests for personal information beyond what is listed above

How We Handle Notices

Upon receiving a valid notice of claimed infringement, we will:

1. Forward the notice to the user who posted the allegedly infringing content
2. Retain records of the notice for a minimum of six months (or one year if legal proceedings commence)
3. Review the content in question and may remove it if we determine it infringes on copyright
4. Take appropriate action against repeat infringers

Safe Harbor Provisions

Under sections 31.1 and 41.27 of the Canadian Copyright Act, Co-Elite Inc., as an online service provider, may qualify for "safe harbor" protection against liability for copyright infringement by our users, provided we comply with the Notice and Notice requirements and maintain an effective repeat infringer policy.

Counter-Notification Process

If we remove or disable access to material based on a valid copyright infringement notice, we will inform you. You may submit a counter-notification that includes:

1. Your physical or electronic signature.
2. Identification of the material that was removed or disabled, along with the location where it appeared before removal.
3. A statement under penalty of perjury asserting that you believe the material was removed due to a mistake or misidentification.
4. Your name, physical address, and phone number.

Termination of Repeat Infringers

Co-Elite Inc. reserves the right to terminate the account or access of any user who is subject to multiple valid copyright infringement notifications, in accordance with our repeat infringer policy.
