

Co-Elite, Inc. Terms of Use

Introduction

These Terms of Use (the "Terms") constitute a legal agreement between Co-Elite Inc. and its affiliates ("Co-Elite," "we," or "us") and you ("you," "your," or "User"). The Terms outline how you may use the services offered through our platform and website located at www.co-elite.com, along with all related online properties (whether linked by Co-Elite or its affiliates) and any software provided by Co-Elite for download, including on mobile devices (referred to as our "Mobile Apps" or "Apps"). Collectively, these platforms and applications are referred to as the "Site."

These Terms also govern your use of all text, data, information, software, graphics, proprietary content, and other materials (collectively, "Materials") that we or our affiliates may make available to you, as well as any services provided through this Site. Together, the Site, the Materials, and the services we offer are referred to as the "Service."

By accessing our website and signing up as a user, you acknowledge that you understand and accept all terms and conditions outlined herein. If you do not agree with any part of these terms, please do not accept them when prompted and refrain from further access to the website and our mobile application. Should you choose not to accept and comply with all terms and conditions, you will be restricted from accessing both the website and the mobile application.

Co-Elite reserves the right to modify these Terms at any time. Any changes will be effective immediately upon posting the updated Terms on the Site. Your continued use of the Service after such changes constitutes your acceptance of the new Terms. It is your responsibility to review these Terms periodically.

By using the Service, you represent and warrant that you are of legal age under the laws of your jurisdiction and/or lawfully able to enter into contracts. If you are a Minor, you represent that you are using the Service with the consent of your parent or legal guardian and that you have obtained their permission to use the Service and agree to its Terms. Data Collection and Analytics

In addition to the data collection practices described in our [Privacy Policy](#), by using the Service you acknowledge and consent to our collection and use of behavioural usage data for the following purposes:

Platform Analytics and Improvement

We collect detailed usage metrics to analyze how users interact with our Service, including profile viewing patterns, search behaviour, content discovery paths, messaging activity, and feature adoption rates. This data helps us improve the Service, develop new features, and optimize user experience.

Recruiting Intelligence Features

For users with Athlete accounts, we collect and may display information about coach interactions with your profile, including views and collections. For Coach accounts, we track your recruiting activity to provide insights and analytics about your search and outreach patterns.

Club Referral Program Data Sharing

For athletes who register using a valid club referral code and provide explicit consent, a limited set of profile and interaction data will be shared with your affiliated sport club. This includes your unique profile identifier, date added to the dashboard, first and last name, primary sport, position, graduation year, recruitment status, whether a profile image has been uploaded (yes or no), and an anonymized count of coach profile views. Coach identities are never disclosed to clubs. This sharing is consent-based and voluntary, and you may withdraw consent at any time by contacting support@co-elite.com. For athletes under 18, parental or guardian consent will be sought before club data sharing is activated.

Service Performance Monitoring

We collect data about account registration flows, onboarding completion rates, profile update activity, and other usage patterns to identify technical issues, measure feature effectiveness, and ensure smooth platform operation.

AI Feature Optimization

When you use AI-assisted features, we collect detailed interaction data including input methods, topic selections, system performance metrics, and content moderation results to improve AI functionality and manage system resources.

Pre-Registration Tracking

When you begin creating an account, we assign an anonymous session identifier to track your progress through registration steps. Upon successful account creation, this session data is linked to your authenticated account to complete our understanding of your user journey.

You understand that this behavioural data collection is integral to providing the recruiting intelligence, matchmaking, and user experience features that define our Service. If you do not consent to this data collection, you should not create an account or use the Service.

All data collection and usage practices are subject to the terms of our [Privacy Policy](#), which is incorporated by reference into these Terms.

Registered Users and Accounts

Sport clubs registered with Co-Elite may be issued a referral code to distribute to their athletes. Athletes who register using a valid club referral code and provide explicit consent will have select profile and interaction data shared with their affiliated club as described in the Club Referral Program section of these Terms. By registering, you confirm that you are (1) at least thirteen (13) years old; and (2) not prohibited from using the Service under these Terms or applicable laws.

Registration Data by Account Type

Athlete Accounts

When registering as an Athlete, the following information is mandatory unless otherwise specified:

- First and last name
- Email address (used as login credentials)
- Password (for account security)
- Location (country, province, city)
- Date of birth (collected to determine eligibility year for athletic recruitment, ensure compliance with child data protection laws, and allow coaches to filter athletes by class year or age group)
- Height
- Sport
- Sport category
- Position
- Grad Year (collected to determine eligibility year for athletic recruitment and allow coaches to filter athletes by class year or age group)
- Status (recreation, committed, free agent)
- Referral Code (optional). Athletes may enter a sport club referral code during registration. Entering a valid referral code will trigger a consent notice explaining what data will be shared with your affiliated club. Data sharing is only activated upon your explicit agreement at the time of registration

Optional information for athlete accounts may include weight, academic interests, personal statement (bio), accomplishments, contact information, career aspirations, community involvement, education details, profile image, and any media uploads to their profile.

Coach Accounts

When registering as a Coach, the following information is mandatory:

- First and last name
- Email address (used as login credentials)
- Password (for account security)
- Location (country, province, city)
- Sport
- Sport category
- Title (e.g., head coach)

Optional information for coach accounts may include current team, organization, level of play, personal statement (bio), accomplishments, contact information, education details, profile image, and any media uploads to their profile.

Student Accounts

When registering as a Student, the following information is mandatory:

- First and last name
- Email address (used as login credentials)
- Password (for account security)

Optional information for student accounts may include personal statement (bio), accomplishments, career aspirations, community involvement, education details, profile image, and any media uploads to their profile.

Registration Responsibilities

When you register for the Service, you agree to (i) provide accurate and complete information ("Registration Data") and (ii) keep it updated. You are responsible for all activities under your Account, so do not share your Account or password. If you notice any unauthorized use or security issues, contact us immediately at support@co-elite.com and log out after each session. If any information is untrue, inaccurate, or incomplete, or if we suspect it is, we may suspend or terminate your Account. You agree not to create an Account with false information and to maintain only one personal Account. Co-Elite Inc. may monitor your username and password and require changes if needed. We also reserve the right to remove or reclaim any usernames, especially if they infringe on third-party rights. You may not register for an Account on someone else's behalf without authorization. Additionally, for athletes who have registered with a club referral code and consented to club data sharing, an anonymized count of coach profile views may be shared with their affiliated club as described in the Club Referral Program section of these Terms. Athletes may receive notifications or see analytics showing which coaches have viewed or collected their profiles. Coaches may see analytics about their recruiting activity and search patterns.

Coach-Athlete Interaction Data

For Athlete accounts, you acknowledge that coaches' interactions with your profile (views, collections, messages) are tracked and may be displayed to you as recruiting intelligence. This data helps athletes understand coach interest and recruiting momentum.

Coach Recruiting Analytics

For Coach accounts, you acknowledge that your recruiting activity (searches, profile views, card collections, messaging patterns) is tracked to provide you with analytics about your recruiting efforts and to help us improve matchmaking algorithms.

Search and Discovery Tracking

When you use search features (such as Athlete Finder) or discovery features (such as Explore), we track your filter selections, search queries, results viewed, and navigation paths. This data is used to improve search accuracy, identify trending content, and optimize discovery features.

No Privacy Expectation in Interactions

You acknowledge that interactions with other users' public profiles and content are not private. Your viewing activity, collection activity, and other interactions with public content may be disclosed to the content owner and used for recruiting intelligence purposes.

Right to Display Interaction Data

Opt-Out Limitations

While you may delete your account at any time, you acknowledge that behavioural tracking is a core feature of the Service. There is no option to use the Service without participating in behavioural data collection while maintaining an active account.

Fair Use of Recruiting Intelligence

You agree to use recruiting intelligence features (such as viewing which coaches have viewed your profile) only for legitimate recruiting purposes. You agree not to use this information to harass, stalk, or inappropriately contact other users.

Club Referral Program

Overview

Co-Elite offers a club referral program that enables registered sport clubs to monitor the recruiting visibility of their affiliated athletes on the platform. Participation is entirely voluntary, free of charge, and requires explicit athlete consent.

How It Works

Sport clubs registered with Co-Elite may be issued a unique referral code to distribute to their athletes. When an athlete creates a Co-Elite account and enters a valid referral code during registration, they will be presented with a clear consent notice describing exactly what data will be shared with their club. Club data sharing is only activated upon the athlete's explicit agreement at the point of registration.

Data Shared With Clubs

Where an athlete has provided consent, the following limited information is shared with their affiliated club via a private dashboard:

- Unique profile identifier
- Date added to dashboard
- First and last name
- Primary sport
- Position
- Graduation year
- Recruitment status (available or committed)
- Whether a profile image has been uploaded (yes or no — no image content is shared)
- A running count of coach profile views (coaches are fully anonymized — no coach identity, name, institution, or identifying information is ever shared with clubs)

No other profile fields, message content, contact information, academic information, or media are shared with clubs.

Athlete Consent and Withdrawal

Your participation in the club referral program is voluntary and consent-based. If you do not enter a referral code, or if you do not agree to the data sharing consent at registration, no data will be shared with any club. You may withdraw your consent at any time by contacting us at support@co-elite.com. Upon withdrawal, your information will be removed from your club's dashboard and no further updates will be provided to your club.

Users Under 18

For athletes under the age of 18, Co-Elite will seek parental or guardian consent before activating club data sharing for that account. Athletes under 18 whose parents or guardians do not provide consent will not have data shared with any club, regardless of referral code entry.

Club Obligations

Clubs that receive athlete data through this program may use it to monitor the recruiting visibility of their affiliated athletes and to promote their club program using aggregated or summarized recruiting metrics (such as total coach views across their athlete roster). Clubs may not share, sell, or redistribute individual athlete data to any third parties outside of their organization, and may not use individual athletes' personal information for commercial purposes beyond internal club promotion.

No Cost; No Data Sale

The club referral program is provided at no cost to clubs or athletes. Co-Elite does not sell or otherwise monetize data shared through this program. Club access is not shared with any other third parties.

Dashboard Infrastructure

Club dashboards are maintained by Co-Elite and accessed by clubs through a private Google Sheet. Clubs are only able to view data for athletes who have registered using their specific referral code and provided explicit consent.

Limitation of Liability

Co-Elite is not responsible for how clubs use the data shared with them through the referral program beyond what is described in these Terms. Athletes assume responsibility for their decision to enter a referral code and consent to data sharing. Co-Elite's general limitations of liability as set out in these Terms apply equally to the club referral program.
