  substantial evidence may be able to be presented in favor or Mr. Piefer's
  qualifications and proximity, relation to the area, the ability to perform the work. The

City Manager could research and present and give sworn testimony and you all could vote off that.

- Vice Mayor Catigano: Spoke on his assessment and if an engineer would know the
  extent of the building. Mr. Piefer advised a structural engineer would know.
- Mayor Taylor: asked the city manager where we would get the money from.
- City Manager John Barkley: Advised there's several line items we could pull from for the assessment.
