# B. Commission Discussion – Fiscal Budget 2025–2026 Process

• City Manager John Barkley provided an overview of the budget process.

### C. Public Input

• Dru Ann Welch: Spoke regarding the Budget vs. Actual report and various line items.

- **Tom Pence:** Commented on the budget.
- **Jim Talbott:** Inquired about paving on Bradbury Street, the lack of certain public works equipment, and questioned whether the city received any funding through its lobbyist.
- Tom Pence: Inquired about attachments for the tractor.
- **Dru Ann Welch:** Brought up budget considerations for special events and the possibility of a bathroom trailer at the Powell property.
- **Janna Taylor:** Asked whether the new program being considered would track ditch maintenance and suggested budgeting for feasibility studies for future projects.

### D. Final Comments from Mayor & Commissioners

- **Commissioner Werning:** Commented on the Budget vs. Actual report and noted line items were not properly categorized.
- **City Manager John Barkley:** Stated the auditor's report would highlight weaknesses that can be addressed.
- Commissioner Werning: Asked when the auditor's report would be completed.
- City Manager John Barkley: Estimated completion in August.
- Commissioner Werning: Voiced support for hiring a part-time accountant.
- Commissioner Werning: Referred to the backhoe as a wishlist item.
- Mayor Taylor: Confirmed the backhoe is on his list as well.
- Commissioner Werning: Supported increased budgeting for community events.
- Commissioner Hyatt: Discussed the events committee.
- **Commissioner Werning:** Expressed interest in re-establishing a Parks and Recreation Committee to host events.
- **Mayor Taylor:** Requested commissioners provide a list of events for the City Manager to share on social media.
- Commissioner Drollinger: Asked if the City's Facebook page was active again.
- City Manager John Barkley: Confirmed that it is.
- Mayor Taylor: Expressed support for purchasing a bucket truck for public works and an enclosed trailer for event chairs.
- Vice Mayor Catigano: Spoke about the City's reserve funds.
- City Manager John Barkley: Noted that the recommended reserve level is 23.5%.
- **Vice Mayor Catigano:** Suggested depositing \$20,000 into the reserve account this fiscal year.
- Commissioner Werning: Asked for an update on remaining ARPA funds.
- Mayor Taylor: Requested City Manager follow up at the next meeting.
- **Commissioner Werning:** Listed capital needs including a tractor, city truck, Ford Escape, and playground equipment.
- Vice Mayor Catigano: Discussed ditch issues and recommended allocating funding for related maintenance.
- Mayor Taylor: Stressed the importance of a ditch maintenance schedule and identifying necessary equipment.
- **Commissioner Drollinger:** Asked the City Manager for an update on the Meade & Hunt project.
