WHEREAS, the City of Oak Hill of Volusia County, Florida, on September 22, 2025, adopted Fiscal Year 2025/2026 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and

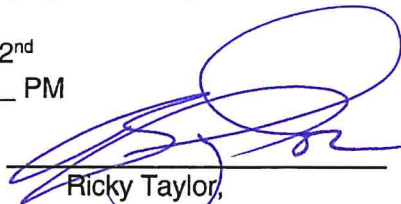
WHEREAS, the City of Oak Hill of Volusia County, Florida, on September 22, 2025, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Volusia County has been certified by the County Property Appraiser to the City of Oak Hill as \$233,060,653.

NOW, THEREFORE, BE IT RESOLVED by the City of Oak Hill of Volusia County, Florida, that:

1. The FY 2025/2026 operating millage rate is 5.6820 mills, which is greater than the rolled-back rate of 5.4037 mills by 5.15%.
2. This resolution will take effect immediately upon its adoption.
