#### **Plan Process**

- Counties are asked to do their best to craft monitoring plans that encompass the monitoring required to assess whether they are meeting goals and benchmarks.
  - o Plans are due (by SCC-county contract) by July 1, 2024.
  - When the county submits a Monitoring Plan (MPlan) it will satisfy the contractual requirements.
- Monitoring plans do not need to conform to any specific format and there are no required elements of a monitoring plan at this time.
  - Counties are encouraged to follow the guidance outlined in the <u>SCC Watershed</u>
     <u>Monitoring Guide</u> (MGuide) to craft monitoring plans. The content in the MGuide
     represents the best guidance for ensuring data obtained through monitoring will be
     useful for adaptive management and five-year reporting within VSP.
- The MPlan is a "living" document that will be updated as necessary over time. SCC will work
  to develop further resources to assist counties to improve and adaptively manage their
  monitoring plans over time.

## **Monitoring Plan Review**

- Trainings via Center for Technical Development and the Science Hub.
- Other resources.

### **Monitoring Plan Sharing**

SCC will post monitoring plans on each <u>county's VSP webpage</u> on the VSP website six months after the July 1, 2024 submittal deadline or on Jan. 1, 2025. This six-month period gives counties the time necessary to respond to requests for clarification or additional information from SCC.

# Does SCC need notice of formal approval of the Monitoring Plan from the county work group?

Work group participation is very important, especially as the monitoring plan is tied to a county's work plan, however, as the use of the <u>SCC Watershed Monitoring Guide</u> (MGuide) is not required, SCC does not require formal work group approval or submittal of work group approval. You are always welcome to share about your efforts to involve your work group, as SCC staff appreciate hearing about your work.
