
# Investment Objective

The fund's investment objective is to generate an absolute monthly return with a target net annual return of 5% in excess of SA inflation. Additionally, the fund strives to minimise risk through disciplined hedging practices and to maintain high levels of liquidity, low concentration risk and low correlation to the equity market.

# Investment Strategy

The fund is a single strategy, market neutral equity hedge fund that focuses on listed South African equities. The fund exploits opportunities within a universe of the more liquid stocks on the JSE. Our investment process is grounded on fundamental analysis incorporating trading dynamics. We screen for relative value using various valuation, growth and return metrics.

Perfect positive correlation (a correlation co-efficient of +1) implies that as one security moves, either up or down, the other security will move in lockstep, in the same direction. If the correlation is 0, the movements of the securities are said to have no correlation.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Risk-return Scatter-Plot: A risk-return scatter-plot illustrates the annualised performance of a fund and benchmarks over the full period of analysis. The relative positioning of the fund versus the benchmarks provides perspective of how the fund has performed on a risk-adjusted basis. The positioning of the fund marker quantifies the volatility (standard deviation on the X-axis) experienced in order to generate the annualised performance (Y-axis) over the period. A position in the top left quadrant is optimal. The fund manager has adopted a risk-return scatter-plot to present performance and corresponding volatility of the fund which will be applied prospectively.

Standard Deviation: It measures the variation of returns around the portfolio's average return.

Sharpe Ratio: Calculated by subtracting the risk-free rate - such as the STeFI-from the rate of return for a portfolio and dividing the result by the standard deviation of the portfolio returns. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been.

### Risk Profiles

Conservative: Generally low risk portfolios have minimal equity exposure or no equity exposure, resulting in far less volatility than a more aggressive mandated portfolio and in turn the probability of capital loss (permanent/temporary) is less likely.
