Textual Information(1)	<p>Mrs Rina Pritish Nandy, Promoter of the Company, has transferred 2,143,638 equity shares to her two daughters, Ms Rangita Pritish Nandy and Ms Ishita Pritish Nandy, who are also Promoters of the Company, in equal proportion. Accordingly, 1,071,819 equity shares have been transferred to each daughter. Pursuant to the transfer, the shareholding of Ms Rangita Pritish Nandy has increased from 643,500 equity shares to 1,715,319 equity shares, while the shareholding of Ms Ishita Pritish Nandy has increased from 575,610 equity shares to 1,647,429 equity shares. Consequently, the shareholding of Mrs Rina Pritish Nandy has been reduced, and she now holds 625,000 equity shares of the Company. There is no change in control of the Company pursuant to the above transfer, as the same has been effected among immediate family members which forms the promoter group, without any consideration, and does not constitute a purchase or sale of shares.</p>
