# Updates on proposal to acquire FSREC Property Fund – Scheme Meeting Results and Next Steps

Equity Trustees Limited ACN 004 031 289 ("Fund RE") as responsible entity of:

- Fort Street Real Estate Capital Fund I (ARSN 163 688 346);
- Fort Street Real Estate Capital Fund II (ARSN 169 190 498); and
- Fort Street Real Estate Capital Fund III (ARSN 605 335 957),

(collectively, the "FSREC Property Fund" or "Fund") announces that Fund Securityholders have at the Scheme Meetings today approved by the requisite majority the proposal pursuant to which ISPT Pty Ltd as trustee for the ISPT Retail Australia Property Trust No. 1 (the "Acquirer") will acquire all of the stapled securities in the Fund it does not own by way of trust schemes (the "Schemes").

## **Voting results of Scheme Meetings**

In summary, the Scheme Resolution to approve the Schemes (being a resolution to amend each Fund Constitution) as set out in the Notices of Meeting dated 22 August 2025, was passed by the requisite majority with 90.63% of votes cast in favour at the Scheme Meetings.

A detailed report of the votes cast in respect of the resolution is annexed.

#### **Next steps**

As announced 11 September 2025 ("Update on proposal to acquire FSREC Property Fund – Notice of Second Court Hearing"), the Fund RE has applied to the Court for orders approving the Schemes and for the provision of the Second Judicial Advice in relation to the Schemes at a hearing scheduled for 19 September 2025.

If the Court approves the Schemes, the Fund RE proposes to lodge an office copy of the Court orders together with copies of the amendments to the Fund Constitutions which will effect the Schemes with the Australian Securities and Investments Commission on 22 September 2025, at which time the Schemes will become legally effective.
