The only third-party integration on this Website is Vimeo, used for hosting and displaying video content. Vimeo tracking and analytics have been disabled, meaning no cookies or personal identifiers are set by Vimeo when you view embedded videos on our pages.

If this configuration changes in future (for example, if additional analytics or third-party tracking is introduced), the Website Privacy Notice will be updated accordingly, and appropriate consent mechanisms will be implemented.

II. Legal Basis and Purposes for Processing of Personal Data

We do not use cookies, tracking technologies, or third-party marketing tools. Website metrics are collected solely through Plausible Analytics, which operates without cookies and does not store personally identifiable information.

Embedded videos are hosted on Vimeo, with all tracking functionality disabled.

III. International Transfers
