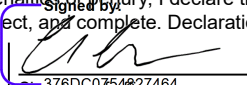

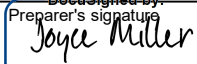

Distributed a total of \$450,000 in scholarship support, through \$410,000 to member state scholarship programs and \$40,000 through the Jim and Sally Hudak Scholarship.
