Sample Language to Include 1% for the Planet in Your Will or Estate Plans

There are many ways to structure a bequest — and we encourage you to consult your legal or financial advisor to determine what’s best for you. Below is sample language you can share with your attorney to include 1% for the Planet in your estate plans:

General (Fixed/Dollar) Bequest

“I bequeath the sum of \$_____ to 1% for the Planet, a 501(c)(3) tax-exempt organization, further classified as a public charity, located in Burlington, Vermont, USA. The employer identification number (EIN) of this organization is 91-2151932.

Percentage Bequest

“I give _____% of the residue of my estate to 1% for the Planet, a 501(c)(3) tax-exempt organization, further classified as a public charity, located in Burlington, Vermont, USA. The employer identification number (EIN) of this organization is 91-2151932.”

Residual Bequest

“I devise the residue of my estate, after the satisfaction of all specific bequests and the payment of all taxes and other costs attending my death, to 1% for the Planet, a 501(c)(3) tax-exempt organization, further classified as a public charity, located in Burlington, Vermont, USA. The employer identification number (EIN) of this organization is 91-2151932.”

Contingent Bequest

“In the event that [name of beneficiary] does not survive me, I designate 1% for the Planet, a 501(c)(3) tax-exempt organization, further classified as a public charity, located in Burlington, Vermont, USA (EIN: 91-2151932), as the devisee of this bequest.”
