President's Message: Summer 2025

With the end of summer approaching we hope you've been able to enjoy more hikes in our cooler than usual summer weather. No, you didn't miss the spring Guardian. We were waiting for the conclusion of the lawsuit against MMWD re the bike plans, then vacations began, and now it's time for the summer issue! The good news is that the lawsuit was settled mostly in favor of the Marin Conservation League, Audubon Society, and Native Plant Society. MMWD has rescinded the two pilot projects which would have allowed bicycles on 7 miles of single track trails as well as Ebikes. Class 1 Ebikes will be permitted on water district fire roads. MMWD was ordered to pay plaintiff's attorneys' fees. However, they will continue to study the feasibility of allowing bikes on certain trails.

The TCC is pleased to fund \$10,000 to the West Point Inn to move a 500 gallon propane tank which had been situated next to the historic 121 year old wooden inn on Mt. Tam. As a major fire has not occurred on Tam since 1945, mitigating fire danger is high on everyone's concerns. The tank was relocated across the Old Railroad Grade fire road. A concrete pad was poured and a trench dug to lay the pipeline to the inn. They now have two 500 gallon propane tanks for their needs as well as to power

their generator when the solar panels do not generate enough electricity. The tanks are located away from any flammable structures.

In April the TCC was again invited to participate at Rep. Jared Huffmann's annual congressional environmental breakfast. Approximately 80 representatives from various organizations in his district met at the Eames Ranch outside Petaluma to share their accomplishments and concerns. A few local political figures were also in attendance. This event provided good networking among our various like-minded groups.

We welcome Sara Boro of San Rafael to our Board. Everyone is invited to our annual meeting and picnic Sunday, September 28, 12 Noon, at the Lake Lagunitas picnic grounds. Eva Buxton from the Native Plant Society is our guest speaker. Come meet your Board and enjoy a wonderful picnic. Be sure to return your ballot or bring it to the annual meeting.
