



GOODYEAR FIA EUROPEAN TRUCK RACING CHAMPIONSHIP

2025 SEASONAL MEDIA ACCREDITATION CRITERIA

All seasonal media accreditation applicants for the Goodyear FIA European Truck Racing Championship (Goodyear FIA ETRC) must comply with the criteria listed below.

PRINT MEDIA

- Please provide details of the publication, including name, editor's name, editor's contacts and approximate circulation.
- Requesting media should provide examples of previous work covering the Championship.

PHOTOGRAPHERS

- Photographers that have attended rounds of the Goodyear FIA ETRC during the 2023 or 2024 season must supply evidence of independent coverage of those rounds.
- Freelance photographers must apply for credentials via their own agencies/media. The onus is on the freelance applicant to prove the regular supply of photos to a publication corresponding to the Goodyear FIA ETRC accreditation criteria. Photo agencies must be able to prove that the pictures have been regularly sold to publications meeting the Goodyear FIA ETRC accreditation criteria. A publication must be able to prove that the pictures published are the original work of the publication's accredited photographer.
- Photographers not complying with the above criteria (promotional and/or commercial photographers) must apply for accreditation to the Goodyear FIA ETRC Media Delegates.

TV & RADIO

- Applications to the Goodyear FIA ETRC Media Delegates for TV access must be submitted by recognised terrestrial, satellite or online channels
- TV applications must be submitted complete with a formal letter of authorisation from an editor or commissioner at the station. This letter should detail the exact content requirements needed from the event and details of the broadcast or broadcasts.

TEAM PR/PRESS OFFICERS/PHOTOGRAPHERS

Please fill in the form below stating which team you are representing.

This should be supplied with a letter or official email from the team confirming that you are representing the team during the season.

WEBSITES/SOCIAL MEDIA

Only sites which are regularly maintained and contain editorial content relevant to the Championship will be considered. Coverage from previous rounds of the Goodyear FIA ETRC must be provided as above.

Only a Level 2 pass will be granted for specialist social media sites such as Facebook groups/pages.

The origin of images on the site must be clearly shown.

There are two types of seasonal media accreditation passes:

- Type 1 - grid, pit lane, paddock, media centre, public enclosures
- Type 2 - paddock, media centre and public enclosures only.

Any media wanting to go trackside need to request a tabard. Anyone allocated a tabard will only be able to collect them at an official media safety briefing.

All media will be asked to sign a standard waiver form when collecting their accreditation.

Applicants should provide a press card or similar for professional identification.

ALL SEASONAL MEDIA ACCREDITATION APPLICATIONS MUST BE RECEIVED BY 5.00PM FRIDAY 2ND MAY 2025.

The decision of the FIA Media Delegates is final in the decisions of granting or not granting media accreditation.

The Goodyear FIA ETRC Media Department considers the media pass to be a working tool to be used only by genuine members of the press.

Publishers, marketing personnel, sub-editors, staff of the publication's secretariat, etc. cannot be accredited as media.
