Your Right to Self-Determination

All residents of nursing homes and licensed assisted living homes are granted rights as persons worthy of dignity and respect. You have a right to a dignified existence and self-determination. These rights are protected under federal and state laws. Employees, families, community agencies and residents must work together in protecting these rights. Your rights to self-determination/choice are as follows:

 Right to choose your personal physician and other providers of services such as pharmacy and hospice



• Right to receive full information, in advance, and participate in your care plan and treatment



Right to refuse care and treatment including medications.
 (Staff should explain to you the possible negative affects of your refusal.)



 Right to choose activities, schedules, and health care consistent with your interests, assessments, and plans of care

- Right to reside and receive services in the facility with reasonable accommodations of your needs and preferences, except when the health or safety of you or other residents would be endangered
- Right to make choices about aspects of your life in the facility that are significant to you such as when you get up and when you go to bed



- Right to interact with members of the community both inside and outside the facility
- Right to voice grievances without punishment and receive a prompt response to your concerns
- Right to organize and participate in Resident Council
- Right to participate in social, religious, and community activities that do not interfere with the rights of other residents in the facility



 Right to keep personal clothing and belongings as space permits unless to do so would infringe upon the rights of others or would create a health or safety hazard



You Want to Move Out?

When I visit the long-term care homes in Vanderburgh County, I often encounter residents who tell me they "want to go home." Moving from the nursing home is not safe for everyone. But, if you don't have severe medical needs and don't need a lot of help from staff, you may be eligible for Money Follows the Person (MFP).

What is Money Follows the Person?

The Indiana MFP Program assists residents in nursing homes move back into the community. The move may be to a home or an assisted living home. While it may be possible to leave a nursing home without the MFP program, some persons find the additional supports from MFP extremely helpful. MFP staff *specialize* in serving the needs and supports of persons who are leaving nursing homes and their services are free.

How do I Qualify?

For you to apply for Indiana's MFP program, you must meet the following:

You must be living in a nursing home

- You must be approved to remain in the nursing home long term
- You must have needs that can be met safely with limited help
- You must be eligible for Indiana Medicaid at least one day prior to discharge from the nursing home

How do I Apply?

What Happens Next?

Professional folks from MFP will work with you to identify your needs and possible supports. If you qualify for the MFP program, they will work to ensure your return to the community is safe and satisfactory.

Michelle's Message

Resident council meetings are the perfect place to make special requests or suggestions that affect everyone.

The Indiana regulations give you, as a Resident of your home, the right to gather and participate in a Resident **Council.** Some Resident Councils are very formal with an elected President and officers. They may follow their own rules or by-laws. Other Resident Councils are very informal with no officers or guidelines. It is up to your council to determine how you wish to operate. It is also up to your council whether you want to meet in private —that is with residents only. Staff and visitors are allowed with your council's permission.

During the meeting, you may discuss concerns, facility operation, residents' rights or other problems. Submit your request or suggestion in writing, and ask for a response in writing as well. If you submit a complaint, try to suggest a solution that suits all residents. Invite staff to participate in council meetings, and perhaps you can reach a solution together. You can request a "Resident Council Action Form" from me that helps with this process.

Get creative! Resident councils can organize fundraisers, publish newsletters, and form special committees to perform certain tasks in a facility.

Please think about inviting me to attend one or more of your council meetings. I would be happy to suggest solutions or ideas and provide information about your rights.

You are not required to participate in a Resident Council, however I recommend you get involved for the benefit of you and other residents in your home. Resident Council is a great way to take ownership in your home and make a positive difference.
