# Un poco de historia ...

## La conferencia de RedOTRI aborda el tema de la profesionalización de la función transferencia

### Conferencia RedOTRI 2011



La Transferencia de Conocimiento como profesión ha sido el objeto de la conferencia anual de RedOTRI celebrada del 1 al 3 de junio de 2011 en Orense. Más de 130 asistentes han debatido sobre los retos profesionales de uno de los campos de actuación prioritarios de la universidad española.



La Universidad de Vigo acogió la edición de 2011 de la Conferencia anual de RedOTRI, que llevó por título "Profesionales en la Función Transferencia". La primera sesión temática estuvo dedicada a los sistemas internacionales de acreditación. En concreto, se presentaron tres modelos: la iniciativa European Knowledge Transfer Society (EUKTS) ligada a la red europea ProTon, la Alliance of Technology Transfer Professionals (ATTP), vinculada a redes como AUTM, ASTP y PraxisUnico y el Certified Licensing Professional (CLP) de la Licensing Executive Society International. Dichas presentaciones corrieron a cargo del presidente de ProTon Europe, Pat Frein, de la directora general de la ASTP Claar-els van Delft y de José Luis de Miguel, presidente de LES España-Portugal, respectivamente.

Today, we proudly support 16 like-minded member associations, offering two main accreditation streams that emphasize continuous learning and recognize individuals’ exemplary professional practice through the attainment of the Recognized Technology Transfer Professional (RTTP) designation.*

Holding an RTTP designation distinguishes you among thousands of professionals in the field, enhancing your credibility and career prospects.

# ¿Qué es la acreditación RTTP?



Según se indica en <https://attp.global/rttp-program/#what-is> :

*“The Registered Technology Transfer Professional (RTTP) accreditation is the only international professional standard for knowledge exchange/technology transfer (KE/TT) and commercialization practitioners working in universities, industry and government labs.*

*RTTP signals personal and professional credibility, and tells employers, colleagues and business partners worldwide that:*

- The individual is an experienced, skilled professional with a proven record of achievement*
- The individual works effectively and creatively to add significant value and deliver outcomes*
- The individual has demonstrated competence, integrity, vision, versatility and perseverance*
- The individual has undertaken relevant training courses and/or gained qualifications that enable them to perform well and build a rich network*
- RTTP invites career advancement, mobility, and international recognition.”*



# ¿Qué es la acreditación RTTP?



- Certificación internacional para profesionales de KT/TT de universidades, empresas y centros públicos de I+D.
- Ayuda a crear confianza con clientes y “stakeholders” sobre las capacidades y experiencia de un profesional de KT/TT.
- Existen **tres modalidades de certificación**:
  - RTTP, antes se denominaba también “Full RTTP”, que es la opción que se va analizar en detalle:
    - “Core Competencies” (competencias básicas)
    - “Requirements & Supporting Evidence” (requisitos y documentación acreditativa)
    - “RTTP Application Process” (procedimiento de solicitud)
  - Candidate RTTP, para profesionales “junior”
  - RTTP Fellow, desde junio 2025



# RTTP: Core Competencies (1)



For RTTP applications, applicants must submit evidence of their skills and achievements in relation to six internationally recognised core competencies of Knowledge Exchange/Technology Transfer (KE/TT) professionals:

- **Strategic & Business Insight** – strategic thinking; market-led, business acumen, and commercial skill
- **Entrepreneurial Leadership** – leadership in building collaboration and partnerships and changing organizations through innovation
- **Legal, scientific and technical knowhow** – understanding and managing the legal, contractual, and domain issues required to effectively exchange and transfer knowledge
- **Effective Engagement** – marketing, promotion, brokering, communication, persuasion and influencing required to bring partners together
- **Governance and Project Management** – managing complex projects to transfer/exchange knowledge and ensuring effective governance and compliance
- **Knowledge Transformation and Management** – administration of systems and processes to support the effective transfer or exchange of knowledge



# RTTP: Core Competencies (2)

## **Perspectiva estratégica y empresarial (Strategic & Business Insight) :**

*Relevant skills/experiences may include:*

*Identifying/sourcing opportunities/initiatives*

*Translating market knowledge into commercial opportunities*

*Scenario building, assessing risks, undertaking due diligence*

*Formulating the vision, setting direction, and securing buy-in*

*Developing the strategy and design of projects/initiatives*

*Defining the market and business strategy and/or the marketing cycle*

*Matching skills, experience, capacity, and resources to opportunities*



# RTTP: Core Competencies (3)

## **Liderazgo empresarial** (Entrepreneurial Leadership):

*Relevant skills/experiences may include:*

*Creating the appropriate environment/climate for KE/TT*

*Overcoming institutional issues or partner barriers through flexible, creative solutions*

*Aligning funding opportunities with strategic aims and priorities*

*Identifying and securing new funding to support KE/TT projects and/or initiatives.*

*Supporting new venture formation, structures, legal frameworks, shareholder agreements, and accessing investment funding*

*Developing and managing community-based or charitable projects*

*Nurturing new ventures/projects until financial independence*



# RTTP: Core Competencies (4)

**Conocimientos jurídicos, científicos y técnicos** (Legal, scientific and technical knowhow)

*Relevant skills/experiences may include:*

*Assessing the technical and scientific attributes and commercial potential of IP*

*Developing an IP exploitation strategy to meet commercial needs*

*Applying different licensing and business models*

*Protecting, packaging, and enforcing any IP needed for the project*

*Drafting, negotiating, and reviewing relevant IP licenses and agreements*

*Understanding and demonstrating expertise in commercial law/finance frameworks*

*Interpreting, advising on, and managing risk*

*Complying with relevant external regulations including national/international jurisdictions relating to legislation, guidance, and commercial and ethical standards*

# RTTP: Core Competencies (5)

## **Compromiso efectivo (Effective Engagement)**

*Relevant skills/experiences may include:*

*Building new networks for research institution/business collaboration*

*Researching and creative planning to identify potential partners*

*Applying the marketing mix to relevant markets/segments*

*Digital Marketing and social media*

*Finding partners, investors, and collaborators*

*Brokering partners and solutions*

*Informing and persuading potential partners*

*Leading, structuring and realising complex negotiation, reconciling different perspectives to achieve resolution e.g., conflicts with lawyers, accountants*

*Managing effective relationships with stakeholders with different cultures or backgrounds e.g. contracts, milestones, deliverables, managing disputes, resolving problems*

# RTTP: Core Competencies (6)

## **Gobernanza y gestión de proyectos (Governance and Project Management)**

*Relevant skills/experiences may include:*

*Establishing governance frameworks for multi-stakeholder projects*

*Developing, setting up, and managing complex projects, e.g., contracts, budgets, milestones, deliverables, decisions, handling information, and reporting on outcomes and successes*

*Compliance with relevant legal, ethical, and project-related requirements*

*Developing, setting up, and managing customer experience/delivering or facilitating outcomes*

*Evaluation – commitment to self-reflection and evaluation, as part of a culture of continuous improvement in both practice, and outcomes to all partners*

# RTTP: Core Competencies (7)

## **Transformación y gestión del conocimiento** (Knowledge Transformation and Management)

*Relevant skills/experiences may include:*

*Knowledge capture and management*

*Knowledge value recognition & reconciliation*

*Administration of knowledge, and information flow*

*Developing, setting up, and managing systems (including ICT systems) to handle knowledge from its creation or capture through to the completion of the objectives and ensuring that information flows efficiently to achieve KE/TT objectives*

*Developing and managing networks and ecosystems*

*Allocation of funding for facilitating knowledge exchange*

## What is needed to achieve RTTP accreditation?

*An individual qualifies for RTTP accreditation by demonstrating their possession of the core competencies through the submission of evidence for the following:*

- 1. Membership with one of the ATTP Organizations*
- 2. Relevant Professional Experience*
- 3. Relevant Skills*
- 4. Achievement requirement*

## 1. Membership with one of the ATTP Organizations

The applicant needs to be a member of an ATTP Associations.

### **Documents to provide in support:**

- Evidence of membership

## 2. Relevant Professional Experience

Applicants must demonstrate that they have worked in a relevant role for a minimum of three years.

### **Documents to provide in support:**

- A letter from the employer confirming the applicant's job title, length of employment, and current work status.
- A resume/CV showing at least three years of professional work experience in role related to knowledge exchange, knowledge transfer or technology transfer within a research organization or institute

## 3. Relevant Skills

Applicants are required to show that they have gained the key skills required to succeed as a technology transfer professional. They have two options to demonstrate this

Option A: Training Route



Option B: Mixed Route



## Option A: Training Route

For recognition of key skills through the training route, applicants must provide evidence that they have earned a minimum of 60 Continuing Education (CE) points. These points can be obtained by participating in ATTP accredited training courses including in-person and online training, webinars, and conference. A comprehensive list of all ATTP accredited training resources is available here ([link to the list of all accredited training](#))

*\*A minimum of 15 CE points out of the 60 CE points must have been gained during face to face ATTP accredited events.*

### **Documents to provide in support:**

- Certificates of attendance in pdf (delivered by the course provider)

# RTTP: Requirements & Supporting Evidence (6)



## Option B: Mixed Route

For recognition of key skills through the mixed route, applicants must provide evidence **or at least two** of the following:

### List of professional qualifications

Applicants are required to submit a brief list of professional qualifications or courses they have attended that are relevant to RTTP core competencies. This should include information on the training or awarding bodies involved. If the applicant has completed RTTP accredited courses but has not earned 60 CE points, these should be listed.

### List of 'deals or projects'

Applicant should provide **a list of at least eight deals or projects** that they has led. These should be chosen to reflect the applicant's level of service and experience, considering the appropriate size, quantity and quality of these engagements.

### Description of leadership roles

Applicant should describe their leadership roles in Knowledge Exchange (KE), Knowledge Transfer (KT) or Technology Transfer (TT), including the size and scope of any teams or initiatives they have directly overseen.

### Documents to provide in support (two or more of the following):

- List of professional qualifications and certificates of attendance evidencing CE points, if applicable
- List of deals or project
- Description of Leadership roles

Recomendable que la “List of Deals” y/o la “Description of Leadership roles” vayan respaldadas por un superior jerárquico.

## 4. Achievement requirement

Applicants must demonstrate that they have applied their knowledge and skills relevant to the six RTTP core competencies listed above to achieve success in one significant collaboration/strategic partnership, a complex commercial project or a significant knowledge transfer initiative.

Applicants that are senior leaders in the profession, with at least five years of leadership experience, can show how they have used their specialist knowledge, skills and experience in leadership to achieve significant outcomes in knowledge exchange, technology transfer.

### **Document to provide in support:**

- The 1000 word Achievement Overview is an essay endorsed by your manager. The Achievement Overview must describe only one of the following options which would not have happened without your input.



Option A: A complex and significant collaboration/ strategic partnership that met the intended goals of the parties

For example: a strategic partnership between a knowledge-based organization and another entity (such as a company, charity, or government agency) aimed at transferring knowledge and delivering tangible societal benefits. This involves developing strategic agreements and gaining senior-level endorsement from both organizations.

The Overview should include the following elements:

- Description of the collaboration/partnership
- Size and scope of the initiative (including financial value if relevant)
- Types of agreements concluded
- Commitment or investment of resources by your organisation and the external partner and level of senior management engagement
- The benefit of the collaboration/partnership to all parties involved and the impact on society (for example generation of new customers and revenues, new products, new investment, new people engaged, income/ profits, documented impacts on society)
- Your specific role in leading and developing the collaboration/partnership, clearly differentiating activity from outcome and showing how you have demonstrated relevant core RTTP competencies.

Option B: A complex and significant commercial outcome which would not have happened without your input

For example: licensing of IP assets, creation of a spin-out company, delivering a major consultancy project or leading a major contract research effort. These activities should be characterised by external investment, market impact and/or increased value for shareholders and stakeholders.

The Overview should include the following elements:

- Description of the project and commercial outcome
- Financial value of the project
- Types of agreements utilised
- Commitment or investment of external resources eg venture funds, corporate funds
- The benefit of the outcome and the impact on society
- Your specific role in making the outcome happen, clearly differentiating activity from outcome showing how you have demonstrated relevant core RTTP competencies.

# RTTP: Requirements & Supporting Evidence (10)

Option C: A significant knowledge transfer initiative that resulted in new capacity, structures, funding, incentives or other developments that enable demonstrable knowledge transfer/ knowledge exchange outcomes.

For example: establishing knowledge transfer networks or communities (e.g., sector networks, national/regional associations), creating funding schemes (proof of concept, venture funds), corporate venturing, entrepreneurship programs, leading incubation/acceleration processes, promoting professional development through people exchanges or structured training, all aimed at improving outcomes for involved communities.

The Overview should include the following elements:

- Description of the initiative
  - Size and scope of the initiative (including financial value if relevant)
- Types of agreements/ structures used in the initiative
- Commitment or investment of external resources in the outcome (eg regional or national government funding, industry funding, funds committed jointly by partners)
- The benefit of the initiative and the impact on society
- Your specific role in leading and developing the initiative, clearly differentiating activity from outcome showing how you have demonstrated relevant core RTTP competencies.

# RTTP: Requirements & Supporting Evidence (11)

For Senior Leaders: Sustained Leadership of KE/KT/TT activity over a number of years, leading a team(s) which has delivered significant KE/KT/TT outcomes due to the specialist knowledge, skills and experience provided by your leadership.

Applicants are expected to be senior leaders in the profession with at least five years' leadership experience. They must be able to show significant leadership demonstrated through long-term performance improvements, effective shaping and management of resources within their organisation(s) and sustained track record of their team(s)'s outcomes.

The Overview should include the following elements:

- The type of leadership role that they have held over a minimum period of 5 years
- The size and scope of the team that they manage (including financial responsibility if relevant)
- The types and volume of work that the team undertakes
- The amount of commitment, investment of resources and level of senior management engagement that they have managed to secure for their team
- The outcomes of the work of the team in terms of their track record ie key KE
- Initiatives, key projects, key partners, key deals and new investment
- Their specific role in leading and developing the team, and specifically how they can demonstrate relevant core RTTP competencies – ie that their knowledge and practice of KE/KT/TTO differentiates them from a generic team manager

# RTTP: Application Process



## **Review of RTTP applications**

*Applications are evaluated by the Peer Review Panel (PRP), a group of Knowledge Exchange / Technology Transfer professionals from ATTP member organizations.*

## **Length of the application process**

*The Review Panel meets quarterly to review applications. All the submission deadlines are published at the end of this page. Once the deadline is met, applicants will be updated on the result of their application within six weeks.*

## **Application fees**

*An application fee for RTTP is US\$300, payable online at the time of application submission. This fee cover one resubmission if requested by the Peer Review Panel.*

## **Resubmission**

*Please note that resubmission for the second time is free for the next two cohorts. After that, a full payment will be required.*

# Peer Review Committee - RTTP

The Peer Review Committee is composed of seasoned RTTPs with extensive experience across various cases and managerial roles. Their diverse backgrounds ensure expert and consistent evaluation of applications from around the world. For each application, PRC members look for evidence that applicants have effectively applied their skills and experiences to challenging cases, demonstrating mastery of the RTTP core competencies.

## What is needed to achieve RTTP accreditation?

*An individual qualifies for RTTP accreditation by demonstrating their possession of the core competencies through the submission of evidence for the following:*

- 1. Membership with one of the ATTP Organizations*
- 2. Relevant Professional Experience*
- 3. Relevant Skills*
- 4. Achievement requirement*
- 5. Pay application fee*

# Candidate RTTP



*Candidate RTTP is a designation that allows entrants to the profession to signal that they have committed to a pathway of training and development leading to the award of full RTTP status. It indicates to employers that these individuals are serious about their career and aspire to meet the highest standards. They may use the designation 'Candidate RTTP' after their name.*

*It is normally expected that Candidate RTTP designation will be sought **approximately six months** into an applicant's employment in KE/TT (typically at the halfway point of a probation period) by which time the Candidate and their manager will be able to judge their suitability and commitment to the Pathway.*

*As with the full RTTP designation, there are three requirements: KE/TT skills, KE/TT experience, and KE/TT achievement.*

*All three requirements can be demonstrated by completing the application form.*

## What are the Candidate RTTP requirements?

### Development of Key Skills

The Candidate is committed to skills development through training or working with a mentor.

### Gaining Professional Experience

The Candidate is working in a KE/TT role and is a member of one of the ATTP Alliance Associations.

### Achievement

The Candidate has developed a Career Aspiration Plan.

The applicant will need to submit two documents to evidence the three above requirements:

## Career Aspiration Plan

Developed by the Candidate and their supervisor/line manager, containing the following sections:

- Current situation and experience of the candidate
- Planned career path of the candidate
- Training/development required by the candidate to achieve their career aspirations including any courses accredited by ATTP, and/or mentoring required/mentor identified to support the Candidate to achieve their career aspiration

## Director's Confirmation

Through a brief, signed statement by the Candidate's line manager or director attesting that:

- The documents uploaded accurately reflect the Candidates' KE/TT roles.
- The line manager or director supports the Candidate's efforts to attain RTTP status through mentoring and/or skills development designed to meet their career aspirations.
- The Candidate has developed a Career Aspiration Plan in consultation with their line manager/supervisor.

# Candidate RTTP (4)

## What is the Application Process for Candidate RTTP?

The application will be checked by the Candidate's national KE/TT association to ensure that all elements of the online process have been correctly followed and in particular that the relevant Director has approved the application.

The association in question will then inform ATTP that all the checks have been performed. ATTP will then register the Candidate, and send an email confirming that the Candidate is now on the Pathway.

Candidates will hear about their application within four weeks following the expiration of the submission deadline as published on our [homepage](#).

## What is the Application Fee for Candidate RTTP?

An application fee for Candidate RTTP is US\$50, payable online at the time of application submission.

*As the global tech transfer communities evolve, ATTP desires to recognize those practitioners who are already in senior or leadership positions with marked contribution to their communities through professional and service leadership. A RTTP Fellow would possess **at least 15 years of relevant tech transfer experience, of which 5 would be in senior roles**. A designate Fellow would clearly be able to demonstrate the quality and contribution related to transformation and changes brought to a particular area in tech transfer, and high-level service to the community. Specifically, the quality and contribution sought would be related to transformation and changes brought to a particular area in tech transfer, with related leadership achievements highly regarded by the peers / immediate stakeholders such as researchers, industries, professional bodies, and prominent NGOs.*

*Emphasis is also given to **service leadership in the tech transfer community at a prominent regional or national level, typically in association with ATTP member associations**. This includes leading initiatives that promote tech transfer, advocating for best practices, and participating in outreach programs. The scheme also looks for individuals who have established national and international partnerships and contributed to global tech transfer efforts, highlighting the importance of fostering collaboration and sharing knowledge across groups and cultures. This **emphasis on community engagement acknowledges the vital role of senior professionals** in shaping the future of the field.*

*The applicant must be affiliated to at least one or more ATTP member associations. If a senior professional would seek the Fellow status without already having attained a RTTP designation, his / her affiliate member association would need to endorse such application in writing. ATTP member associations (full and associate) can also formally nominate qualified individuals to be considered as Fellows.*

# RTTP Fellow (2): Application Guidelines



## Attributes and Leadership

For seasoned tech transfer professionals seeking RTTP Fellow status, they would be expected to demonstrate their professional achievements and service leadership in relation to the 4 areas with impact:

- Professional Leadership and Impact
- Service Leadership in TT Community
- Recognition and Influence
- International Outreach

# RTTP Fellow (3): Application Guidelines



## 1. Professional Leadership and Impact

- Initiatives Led: Specific projects or programs initiated by the applicant that exemplifies his/her leadership in tech transfer, with notable contribution and impact among its peers, advancing specific technological sectors or industrial fields through supporting TT initiatives and development programs.

## 2. Service Leadership in TT Community

- Service to TT Associations / Professional Bodies: Demonstrated commitment and history in undertaking functional / executive roles in standing committees and boards of member associations or related international professional bodies.
- Capacity Building Efforts: Involvement in national / international programs or workshops designed to develop the skills of tech transfer professionals, demonstrating a dedication to enhancing the global capacity of the community.
- Mentorship Roles: Evidence of mentoring individuals and groups from diverse backgrounds, highlighting their commitment to fostering talent and enhancing skills in tech transfer.

## 3. Recognition and Influence

- a. Awards and Honors: Any awards, recognitions, or honours received for contributions to tech transfer or related fields, particularly for outreaching and capacity-building initiatives by member associations, professional bodies and government agencies
- b. Public Services: A record of influential engagements (as advisors / committee members), conference presentations, or thought leadership contributions that emphasize the importance of tech transfer in the innovation ecosystem outside of own TT association(s).

## International Outreach

- Evidence and passion in engaging trans-national advocacy and capacity building activities, through training, conference speaking, and related advisory roles.

# RTTP Fellow (5): Requirements

## Requirement & Supporting Evidence

1. Membership or affiliation in case of institutional membership with one of the ATTP member organizations.

2. Document to evidence career pathway, service track record and impact.

2a: Full Curriculum Vitae.

2b: Personal Statement (approx. 1,000 words) – an account of the profile of the applicant rather than an essay, on contributions and impact desired in the Fellowship profile.

Item 1 should be produced or certified by the applicant's member association.

Item 2a and 2b should be endorsed by the applicant's employment supervisor, or in case of a retiree / self-employed individual, by one of the current board members of his/her member association.

# RTTP Fellow (6): Application process

## RTTP Fellow Application Process

### Review of RTTP applications

Applications are evaluated by a senior sub-group of the Peer Review Committee (PRC), comprised of seasoned and well acclaimed tech transfer professionals from ATTP member associations. Each application will be reviewed at least 3 assessors outside of the applicant's affiliated member association, typically from a different country / sub-continent. In case of difference in opinions, the Chair of the PRC will seek further opinion from other senior assessor(s) for the final decision.

### Length of the application process

The Review Panel meets quarterly to review applications, with submission deadlines in synchrony with that of the RTTP application unless otherwise announced.

Applicants will be notified of the result typically in about 6 weeks.

# RTTP Fellow (7): Application fee

## What is the application fee for Fellow RTTP?

An application fee for RTTP is US\$200, payable online at the time of application submission. This fee cover one resubmission if requested by the Peer Review Committee within the 6 months from the date of the first submission.

## Subsequent Annual fees

The application fee would cover the assessment and the first 12-month period of registration for the RTTP Fellow designation. The subsequent annual fee will be US\$100\* per year, payable pro rata on the first anniversary month of the successful application for the current calendar year, and due on January 1 for the third calendar year onward.

\*Individuals over 60 years of age or those no longer under full time employment may enjoy a 20% discount of the annual fee.

(For example, applicants awarded with the RTTP Fellow designation in June 2025 will only need to pay \$50 for July-December 2026, before renewing their status for 2027 with \$100 due on January 1, 2027)


