- 1. See Design Pressure (**DP**) charts: sizes Vs glass types, interlock/astragal reinforcing and Head receptor options, in sheet <u>3</u>. See SGD door mullions (M1, M2 & M3) load capacity in sheet <u>4</u>. See Head and Sill anchor capacity charts in sheet <u>5</u>. Lower Design Pressure shall control from the charts, for entire assembly.
- 2. When SGD door jamb is mulled (mated) per sheet <u>4</u>, the mating mullion is integral part of the capacity with min sectional properties, as listed. Additional mating per series 101 Window wall is under separate approval, to be reviewed by Building official.
