

MFAN is a leading voice at the forefront of defining the new landscape for U.S. international assistance. We develop timely and actionable recommendations to guide the future of U.S. development and humanitarian assistance.



Our Legacy & Impact

- MFAN was the first group to release (in March 2025) recommendations for the State-USAID reorganization. After convening an ideologically diverse group of former Republican and Democratic officials, foreign policy experts, and leading development practitioners, in July 2025 we released a comprehensive set of recommendations to guide the future of U.S. foreign assistance.
- In 2023, we led the relaunch of the bipartisan Congressional Caucus for Effective Foreign Assistance, under the new leadership of co-chairs Reps. Young Kim (R-CA) and Adam Smith (D-WA). We have hosted several congressional staff briefings in conjunctions with Caucus three in the first half of 2025 alone.
- MFAN has helped with the formulation several major bipartisan foreign assistance bills, including the Foreign Aid Transparency and Accountability Act of 2016 (FATAA) and the Better Utilization of Investments Leading to Development Act of 2018 (BUILD Act), which created the U.S. International Development Finance Corporation.
- We successfully advocated for the elevation of USAID as a permanent member of the National Security Council under the last Administration, and we worked with USAID and Congress to bolster the agency's locally led development and use of strong and transparent metrics.
