Our Legacy & Impact:

MFAN’s approach – combining bipartisan engagement, technical expertise, and actionable recommendations – has delivered measurable policy and legislative impact:



- **Shaping the Future of U.S. Foreign Assistance Reform:** In March 2025, MFAN was the first organization to release recommendations on the State Department – USAID reorganization. We convened an ideologically diverse group of former Republican and Democratic officials, foreign policy experts, and leading development practitioners, culminating in the release of consensus principles and recommendations in July 2025 to guide the future of U.S. international assistance. In September 2025, we also published a landmark analysis identifying critical gaps in the State Department’s operational capacity, including staffing, technical expertise, and oversight systems, needed to effectively manage an expanded U.S. foreign assistance portfolio. In February 2026, MFAN released an operational roadmap to help the U.S. government implement government-to-government (G2G) assistance effectively, manage risks, and strengthen partner country systems.
- **Revitalizing Bipartisan Congressional Leadership:** In 2023, MFAN led the relaunch of the bipartisan Congressional Caucus for Effective Foreign Assistance, under the leadership of co-chairs Reps. Young Kim (R-CA) and Adam Smith (D-WA), restoring a key bipartisan platform for foreign assistance reform. Since then, we have hosted multiple congressional staff briefings in partnership with the Caucus on key topics such as aid accountability and transparency; innovation; Global Health-G2G assistance agreements; and reauthorization of the U.S. International Development Finance Corporation (DFC).
- **Influencing Landmark Bipartisan Legislation:** MFAN has played a critical role in shaping several major bipartisan foreign assistance bills, including the Foreign Aid Transparency and Accountability Act of 2016 (FATAA) and the Better Utilization of Investments Leading to Development Act (BUILD Act) of 2018, which established the DFC – fundamentally modernizing how the U.S. partners with the private sector to advance development. MFAN is working with congressional offices on authorizing legislation on the future of U.S. international assistance and provides ongoing input into appropriations and authorization bills, helping improve how assistance is designed, implemented, and evaluated.
