#### 5. Add Ons

## 5.1. Eligibility

The Add Ons shall be applicable to all CelcomDigi Postpaid customers (herein defined as "Customer").

### 5.2. Add Ons Subscription

- 5.2.1. The Daily Roaming Pass is a roaming service that comes with roaming Internet quota of up to 2GB at RM39 flat rate per day:
  - 5.2.1.1. The quota allocated will be high-speed roaming Internet.
  - 5.2.1.2. After the full quota is used, the subsequent internet speed will be throttled to up to 256kbps.
- 5.2.2. Daily Roaming Pass is offered in partnership with network operators in the selected countries ("<u>Participating Network Operators</u>"). CelcomDigi reserves the right to delete, add or amend the list of Participating Network Operators in the selected countries from time to time.
- 5.2.3. This Daily Roaming Pass shall be auto renewed if data usage continues to be detected after 24 hours from the activation time. Customers may avoid the auto-renewal and/or the Charge by turning off their Data Roaming.
- 5.2.4. In the event that the Customer did not purchase a roam pass or subscribed to Roam Like Home, the Daily Roaming Pass service will be automatically activated once the Customer reaches the foreign country, and the Daily Roaming Pass service will continue to auto-renew every 24 hours with a RM39 charge as long as international roaming is enabled in the device of the Customer.



- 5.2.5. The Daily Roaming Pass service shall be used outside of Malaysia and the Customer agree to abide by and be subjected to all terms and conditions of use at all times and the usage terms of the Participating Network Operators.
- 5.2.6. Customer shall not use the Daily Roaming Pass for commercial, non-personal or fraudulent use or gains. CelcomDigi reserves the right at any time at its absolute discretion and without any liability whatsoever to the Customer or any third party, to disconnect, interrupt, terminate, bar or suspend the Daily Roaming Pass service to a Customer in the event of suspicious usage, illegal activities, suspected fraud or any other unusual activities that are not permitted under this Terms and Conditions.
- 5.2.7. There will not be any refund granted on unutilized Daily Roaming Pass Quota upon termination at any point of time if the Customer deactivates International Roaming. The remaining Internet quota will be forfeited with immediate effect.

#### **General Terms**

- 1. CelcomDigi shall not be responsible in any way in the event that the Customer's subscription is activated by a 3rd party without their consent. CelcomDigi shall not refund nor compensate the Customer in any manner whatsoever in such situations.
