

CelcomDigi – Disney Jr. Live On Tour: Let's Play! ("Contest")

This Contest is held by CelcomDigi Mobile Sdn. Bhd. (formerly known as Celcom Mobile Sdn. Bhd.) (Company No. 197601002188 (27910-A)) ("**Celcom**") and CelcomDigi Telecommunications Sdn. Bhd. (formerly known as Digi Telecommunications Sdn. Bhd.) (Company No. 199001009711 (201283-M)) ("**Digi**") (Celcom and Digi are collectively known as "**CelcomDigi**" for the purpose of this Contest.)

This Contest will be governed by these terms and conditions and any subsequent accompanying contest details (if any), Celcom's and Digi's Privacy Notice, Data Protection Statement and Data Protection Obligations found on Celcom's and Digi's respective website at [Celcom Privacy Notice](#) and [Digi Privacy Notice](#) (collectively referred to as the "**Terms**"). Each Eligible Participant (as defined below) agrees that he/she has read and understood the Terms and by his or her participation in this Contest, each Eligible Participant agrees to be bound by the Terms.

The Walt Disney Company and its parents, affiliates and subsidiaries are not responsible for the promotion, administration or execution of this Contest.

1. Contest Period

- 1.1. This Contest consists of two separate contest periods:
 - 1.1.1 **CelcomDigi Facebook Contest** runs from 8.00 a.m. on 29 July 2025 to 11.59 p.m. on 3 August 2025; and
 - 1.1.2 **ERA FM Radio Activation** runs from 8.00 a.m. on 4 August 2025 to 11.59 p.m. on 8 August 2025(collectively referred to as the "Contest Periods")
- 1.2. Entries submitted outside the respective Contest Periods will be automatically disqualified. CelcomDigi reserves the sole and absolute discretion to amend, extend, or vary the Contest Periods at any time without prior notice.

2. Eligibility Criteria

- 2.1. All (i) CelcomDigi's postpaid, prepaid and fibre subscribers; and (ii) individuals with an active and valid mobile number from any licensed telecommunications provider in Malaysia, residing in Malaysia are eligible to participate in this Contest (excluding persons mentioned in Clauses 2.1.1 to 2.1.3 below, "**Eligible Participants**"):-
 - 2.1.1. permanent, contract and temporary employees of CelcomDigi and their Immediate Family Members; and
 - 2.1.2. employees of CelcomDigi's partners, advertising, promotion agencies and any other persons involved in organizing, promoting and/or

conducting this Contest together with their Immediate Family Members.

2.1.3. Immediate Family Members shall mean any of the following: spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

2.2.1. agrees to be bound by the Terms; and

2.3. All personal details submitted must be accurate and complete and are subject to proof upon request by CelcomDigi.

2.4. CelcomDigi reserves the right, at any time, to verify the validity of entries and entrants and to disqualify any entry not submitted in accordance with the Terms or which tampers with the entry process. Incomplete, indecipherable, illegible, incorrect or fraudulent entries or any entry which violates the Terms will automatically be disqualified without any notice.

3. Contest Mechanics

The Contest will be conducted through three (3) separate methods, namely **ERA FM Radio Activation**, **ERA FM Social Content** and CelcomDigi **Facebook Contest**. Eligible Participants may take part in either or all methods, provided all applicable terms are met.

In order to participate in the Contest, the Eligible Participants need to carry out the following steps:

3.1. Method 1: ERA FM Radio Activation

Step 1 : Eligible Participant to call in to ERA FM after the cue to call for contest participation

Step 2 : Eligible Participant to say the phrase 'Disney Junior on Tour Bersama CelcomDigi dan Era' in the voice of Mickey Mouse or any other Disney character of their choice

- Step 3 : Eligible Participant with the correct answer will be eligible to win Disney Jr. Live On Tour: Let's Play! Tickets

3.3. **Method 2: CelcomDigi Facebook Contest**

- Step 1 : Visit <https://www.facebook.com/CelcomDigi>
- Step 2 : Locate the "CelcomDigi X Disney Jr. Live On Tour: Let's Play!" contest post.
- Step 3 : Eligible Participant must comment which three Disney Junior characters they would invite to the Mickey Mouse Clubhouse for a playdate and explain why.
- Step 4 : Eligible Participant must follow CelcomDigi on Facebook, like and share the contest post on his or her profile and tag 3 (three) friends. The Eligible Participant's Facebook profile must be set to public and be accessible by CelcomDigi for viewing.

The most liked comments will be eligible to win Disney Jr. Live On Tour: Let's Play! Tickets

4. **Notification and Selection of Contest Winners**

- 4.1. Selection of the contest winners for this Contest will be based on the following: -

4.1.1. **Method 1: ERA FM Radio Activation**

- i. Five (5) winners will be selected by ERA FM based on their ability to call in to ERA FM during the allotted time and correctly answer the contest question as determined by ERA FM's host.
- ii. Shortlisted Eligible Participants are required to provide the information to ERA FM in full:

 - b. Full NRIC Number
 - c. CelcomDigi Mobile Number
 - d. Delivery Address

4.1.2. **Method 2: ERA FM Social Contest**

- i. Five (5) winners will be shortlisted based on their completion of all contest requirements set by ERA FM from time to time, which includes completing the sentence from the contest post selected by ERA FM. Among the shortlisted Eligible Participants, five (5) winners will be selected based on the most liked comments calculated from the time the Contest post is published on the ERA FM Facebook and Instagram page.
- i. Shortlisted Eligible Participants are required to provide the information to ERA FM in full:
 - a. Full Name (as per NRIC)
 - b. Full NRIC Number
 - c. CelcomDigi Mobile Number
 - d. Delivery Address

4.1.3. Method 3: CelcomDigi Facebook Contest

- ii. Eligible Participants will be shortlisted based on their completion of all contest requirements set by CelcomDigi from time to time, which includes completing the sentence from the contest post, following CelcomDigi on Facebook, and sharing the contest post on his or her profile (which is required to be set to public to be accessible by CelcomDigi for viewing). Among the shortlisted Eligible Participants, ten (10) winners will be selected based on the most liked comments calculated from the time the Contest post is published on the CelcomDigi Facebook page.
- iii. Shortlisted Eligible Participants are required to respond to CelcomDigi's request via Direct Message ("DM") on Facebook by providing the following information in full:
 - a. Full Name (as per NRIC)
 - b. Full NRIC Number
 - c. CelcomDigi Mobile Number
 - d. Delivery Address

Failure to respond to CelcomDigi's request via DM within the stipulated timeframe or failure to provide complete and accurate details will result in disqualification.

- i. met the winning requirements and selected by ERA FM as winner under ERA FM Radio Activation; and

- ii. respond to ERA FM's DM with all the required information and meet all other eligibility criteria as set by ERA FM from time to time for the Social Contest;
- iii. respond to CelcomDigi's DM with all the required information and meet all other eligibility criteria as set by CelcomDigi from time to time for the Facebook Contest;

will be confirmed and announced as contest winner ("**Contest Winner**").

- 4.2. The Contest Winner will be contacted and officially notified of the winning status via CelcomDigi's authorized WhatsApp channel to his or her mobile phone number in CelcomDigi's record 2 weeks within the Contest period but no later than by **1st September 2025** ("**Collection Period**"). CelcomDigi has the sole and absolute discretion to extend the Collection Period. The Contest Winners must keep their mobile phone numbers valid and activate during the Collection Period.
- 4.3. CelcomDigi must be able to contact the Contest Winner via two (2) attempts during the Collection Period, failing which CelcomDigi reserves the right to move on and select another Contest Winner if the initial Contest Winner is not contactable within three (3) working days from the first attempt. The non-contactable Contest Winner shall be automatically disqualified as Contest Winner and he or she shall have no claims whatsoever against CelcomDigi on such disqualification.
- 4.4. The Contest Winner must physically and personally collect the Tickets. If the Contest Winner is unable to personally collect his or her Tickets personally, he or she must provide a letter of authorization to authorise another person to collect the Tickets on his or her behalf. The identification card of the authorised person must be produced upon receipt of the Tickets. CelcomDigi shall not be liable to any consequence in the event the Tickets are released pursuant to any letter of authorization received. By participating in this Contest, each Eligible Participant agrees and consents to Celcom's and Digi's Privacy Notice, Data Protection Statement and Data Protection Obligations found on Celcom's and Digi's respective website at [Celcom Privacy Notice](#) and [Digi Privacy Notice](#) that all details submitted pursuant to this Contest, including without limitation personal data/information being collected, processed and used by CelcomDigi for:-

6.1. the purpose of this Contest; and

6.2. marketing and promotional activities conducted in such manner as CelcomDigi sees fit worldwide in any media including without limitation the Internet, without further express consent from, and payment or consideration to the relevant Eligible Participants. Marketing and promotional activities include without limitation the use and/or publication of any details provided in and/or in connection to the entries, interview material as well responses and related

photographs. In this regard, each Eligible Participant agrees to co-operate and participate without further express consent and/or payment or consideration, in all reasonable advertising and publicity activities of CelcomDigi relating to this Contest; and

- 6.3. other promotional, marketing and publicity notification/information including future promotional, marketing and publicity notification/information from CelcomDigi from time to time.
7. In addition, where any of the data/information especially personal data relating to the Eligible Participant and/or third parties (where applicable) are submitted to CelcomDigi and/or by any entrant in connection to this Contest, each:-
 - 7.1. warrants that he/she is in possession of all necessary consents and shall continue to maintain such consents as may be required for CelcomDigi and/or usage and processing of such data/information; and

 - 9.3. That CelcomDigi and/or the Specified Persons shall not be liable for and hereby expressly exclude any losses, damages, rights, claims and actions of any kind (including without limitation loss of damage to property or any personal injury or loss of life, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties) howsoever arising whether in contract, tort, negligence or otherwise, in connection with this Contest, and/or the Prizes, even if CelcomDigi

has been advised of the possibility of such damages in advance, whether or not due to and/or arising from:-

- 9.3.1. telephone, electronic, hardware or software program, network, Internet, server or computer malfunctions, failures, interruptions, miscommunications or difficulties of any kind, whether human, mechanical or electrical, including, without limitation to, the incorrect or inaccurate capture of entry information online;
- 9.3.2. late, lost, delayed, misdirected, incomplete, illegible or unintelligible e-mails;
- 9.3.3. virus attacks and/or any other malicious software infection to the Eligible Participants'/subscribers' mobile phones arising from the downloading of these contents, any failed, incomplete, lost, garbled, jumbled, interrupted, unavailable or delayed electronic transmissions;
- 9.3.4. any default or condition caused by events beyond the control of CelcomDigi including those due to any act of God, war, riot, strike, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of CelcomDigi;
- 9.3.5. any printing or typographical errors in any materials associated with this Contest; and
- 9.3.6. any claims by third party for infringement of intellectual property rights.

Specified Persons shall mean CelcomDigi, and its employees, officers, directors, shareholders, parent companies, affiliates, subsidiaries, licensees, agents, representatives, partners and contractors including contradvertising, promotion, and fulfilment agencies, and legal advisors and/or joint-organiser.

10. CelcomDigi:-

- 10.1. reserves the right, at any time, to verify the validity and/or reject any entries at its sole and absolute discretion without having to assign any reasons whatsoever. - 10.2. reserves the right to disqualify a Contest Winner if he/she is found to be ineligible at any point of time and to cancel/withdraw/recall the Prizes from being delivered to the ineligible Contest Winner. For the avoidance of doubt, cancellation, termination or suspension by CelcomDigi of any entry or this Contest shall not entitle the Eligible Participants to any claim or compensation against CelcomDigi for any and all loss or damage suffered or incurred by the Eligible Participants as a direct or indirect result of the act of cancellation, termination or suspension.

12. A failure by CelcomDigi to enforce any of the Terms in any instance(s) will not give rise to any claim by any person.
13. All other terms and conditions governing the use of any of CelcomDigi's mobile telecommunication services shall apply herein mutatis mutandis.
14. The Terms shall be governed and construed by the laws of Malaysia and the parties shall submit to the exclusive jurisdiction of the Courts of Malaysia.
