2.4 Each Mobile Station International Subscriber Directory Number (MSISDN) may have only one (1) active contract with CelcomDigi at a time and Offer 2 is available only to Customers without an existing active contract on the same MSISDN.



(d) Other Conditions

- iii. This Add Ons is not available to Customers with any outstanding bills and/or if their line is suspended or deactivated by CelcomDigi.
- iv.
