- 3.1.5. Multiple subscriptions of the same add-ons are not allowed.
- 3.1.6. If Eligible Participant has an active StreamMORE Disney+ Add Ons subscription and subscribe to another StreamMORE Disney+ Add Ons thereafter, the former subscription shall be dropped, and the latter add-ons subscription shall start immediately. For clarity purpose, both subscriptions shall be charged in full.

- 3.2.1. By subscribing to Mega Add-Ons Disney+, Eligible Participants agree to be charged a fixed monthly subscription price throughout a 12-month contract period, starting from the date of successful Mega Add-Ons Disney+ subscription.
- 3.2.2. The subscription price for Mega Add-Ons Disney+ is subject to CelcomDigi's prevailing pricing structure, which is subject to revision from time to time at CelcomDigi's absolute discretion.
- 3.2.3. CelcomDigi's Mega Add-Ons Disney+ price may include value-added benefits, promotions or discounts, which may differ from the Recommended Retail Price ("RRP") as published by Disney+.
- 3.2.4. The subscription price for all Eligible Participants at the time of Mega Add-Ons Disney+ subscription or renewal is based on the latest published prices on CelcomDigi Website.
- 3.2.5. Any revision to the subscription price of Mega Add-Ons Disney+ shall take effect on the date as stated on CelcomDigi Website.
- 3.2.6. Any revision to the subscription price may apply immediately on new subscriptions and/or existing subscription upon renewal, upgrade, or plan migration at CelcomDigi's absolute discretion.
- 3.2.7. The given quota is on high-speed internet and can be used for tethering.

- 3.2.12. The Mega Add-Ons Disney+ access is tied to the CelcomDigi mobile number used for activation / subscription and is not transferable.
- 3.2.13. Upon successful subscription, the full monthly subscription price shall be applicable and is non-refundable under any circumstances, including but not limited to service line termination, cancellation of add-ons, switching out of Disney+, or migration to a non-eligible rate plan.
- 3.2.14. Multiple active subscriptions to the same Mega Add-Ons Disney+ is not permitted.

- 3.4.5. Once the subscription is successful, full charges shall apply with no refund allowed. This applies to events including line termination or change of rate plan not stated in Clause 2.5.2.
- 3.4.6. In the event of line termination, any unutilised quota and/or calls shall be forfeited, and Disney+ access is terminated with immediate effect.

3.4.10. If Eligible Participant has an active StreamMORE Disney+ (Basic) or SpeedSTREAM Disney+ (Basic) subscription, the said subscription shall remain valid for a period of thirty (30) days ("Validity Period"), regardless of any early termination of the subscription by the Eligible Participant. If Eligible Participant switches subscriptions between different Add Ons within the Validity Period,



the current subscription shall be terminated, and the latter subscription shall start immediately. The new quota shall also start immediately according to the latter subscription.
