4. CelcomDigi reserves the right to terminate, suspend or block a Customer's usage of its services for any reason at any time without prior notice. 5. Add Ons

(a) Availability

This Add-Ons shall commence on 21 August 2025.

Any changes or discontinuation thereof shall be at the sole discretion of CelcomDigi.

(b) Eligibility

The Add Ons shall be applicable to all CelcomDigi Postpaid and Prepaid customers (herein defined as "**Customer**").

- 1.1 Offer 1 shall be purchased through the CelcomDigi App, Celcom Life App or MyDigi App, depending on the applicable App, or by walk-in to any of CelcomDigi's physical retail or franchise outlets.
- 1.2 Customer who subscribes to Offer 1 shall entitle to a Promotional First-time Subscription Fee from 21 August 2025 to 31 March 2026, both dates inclusive. Subsequently, subscription fee shall automatically renew at the Promotional Subscription Renewal Fee, unless cancelled by the Customer prior to renewal.
- 1.3 Once the purchase is successful, full charges shall apply with no refund allowed. This is applicable to events including line termination, early cancellation of Add-Ons, and change of rate plan to non-eligible rate plans.

However, CelcomDigi does not guarantee the timeliness of the subscription renewal and shall not bear responsibility for any damages incurred directly or indirectly due to a delayed or failed renewal within the stipulated renewal window as stated in this clause.
- 1.6 If the renewal fails for any reason whatsoever, CelcomDigi shall send notification via SMS to the Customer to inform the Customer of the failure. Failure of renewal may be due to inter alia either insufficient credit in the Customer's main credit balance OR the Customer is currently in inactive status due to validity. However, CelcomDigi shall not bear responsibility for any damages incurred directly or indirectly due to or consequences of failure to send out the SMS notification within the stipulated renewal window as stated in this clause.
- 1.7 In the event of a failed renewal due to insufficient credit or suspended status due to validity, CelcomDigi shall renew such subscription once the Customers had made the necessary top up or reload.
- 1.8 The Add-Ons are on auto-renewed subscription. THE CUSTOMERS MUST TERMINATE THEIR SUBSCRIPTIONS IF THEY WISH TO DISCONTINUE THEIR SUBSCRIPTIONS.
- 1.9 In the event of early cancellation of Add-Ons or termination of the Customer's mobile number, the subscription is also terminated with immediate effect

2.5 During the Term, in the event the Customer opt to change from one Freedom Add-Ons Contract to another or to add devices offerings ("**Change(s)**") shall be subjected to the following conditions:

- a) If Customer performs a Change any time before the 12-month contract expiry, Customer shall pay an early termination fee for premature termination of the said contract;
- b) The early termination fee is calculated as follows:
Recommended Retail Price (RRP) of RM3.00 × Remaining Term
- c) Subject to the effective date of the Change, all benefits from the previous contract shall be forfeited and new contract date shall commence on the effective date of the Change;
- d) CelcomDigi reserves the right to charge any administrative fee arising from each Change request by the Customers

2.6 During the Term, in the event the Customer opt to upgrade his/her Postpaid plan to a higher value plan, the terms of the Contract shall remain unchanged

2.7 During the Term, in the event the Customer opt to downgrade his/her Postpaid plan to a lower value plan, the terms of the Contract shall be terminated, and Customer shall subject to a penalty fee as outlined in Clause 2.5 (a) and (b) for termination of the Terms and Conditions

(d) Other Conditions

1. The Add-Ons cannot be transferred to any other mobile number. Multiple subscriptions of the same Add-Ons are not allowed.
2. Customers shall maintain an active CelcomDigi line to subscribe to the Add-Ons. For clarity, active means the Customers shall be able to make and return calls.
