

SafePAY Jr (“Add Ons”)

SafePAY Jr is a subscription service that empowers parents to guide their kids in managing money wisely and safely, giving children access to Vircle Card with spending under parental control.

- ii. Each Customer shall sign-up for this Add Ons either via CelcomDigi website or CelcomDigi App. From there, select Vircle Visa Prepaid Card ("**Vircle Card**") and fill up the address to arrange for delivery of the Vircle Card.
- iii. SafePAY Jr – One time processing fee of RM10 shall be charged to the Customer's Postpaid bill once the Customer completes the sign up.
- iv. Upon receiving the Vircle Card, each Customer shall be required to download the Vircle App to activate the Vircle Card.
- v. Table 2 states the details of Add Ons subscription ("**Subscriptions**"):

*Subscription Fee is exclusive of the 6% Sales and Service Tax (SST).

- vi. Subscription Fee shall be charged monthly upon the activation of Vircle Card to the Customer.

- vii. The Customer who subscribes for the first time between *16 December 2025 to 31 March 2026* shall be entitled to a promotional subscription fee of RM1 for the first month, both dates inclusive ("**Campaign**").
- viii. Subsequently, the Subscription shall automatically renew at the prevailing Subscription Fee of RM8 per month, unless the Subscription is cancelled by the Customer prior to renewal.

Other Conditions

- i. The Subscription cannot be transferred to another mobile number.
- ii. Each SafePAY Jr Add Ons shall be linked to only one principal line with CelcomDigi at any time.
- iii. The Customer shall maintain an active Celcom or Digi line to subscribe to the Add Ons.
- iv. This Add Ons is not available for the Customer with any outstanding bills and/or if their line is suspended or deactivated by CelcomDigi.
- v. CelcomDigi shall send an SMS notification upon successful renewal. However, CelcomDigi does not guarantee the timeliness of the Subscription renewal and shall not bear responsibility for any damages incurred directly or indirectly due to a delayed or failed renewal within the stipulated renewal window as stated in this clause.
- vi. If the renewal fails for any reason whatsoever, CelcomDigi shall send notification via SMS to the Customer to inform the Customer of the failure. Failure of renewal may be due to the Customer is currently in inactive status due to validity. However, CelcomDigi shall not bear responsibility for any damages incurred directly or indirectly due to or consequences of failure to send out the SMS notification within the stipulated renewal window as stated in this clause.
- vii. In the event a renewal fails due to the Customer's line being suspended or whatever reason, the Vircle Card will be terminated. The subscription will not be reinstated even if the Customer subsequently restores active status. The Customer will be required to sign up again for new Vircle Card and

complete the full card activation process again should they wish to re-subscribe.

- viii. This Add Ons is on auto-renewed subscription. THE CUSTOMERS MUST TERMINATE THEIR SUBSCRIPTIONS IF THEY WISH TO DISCONTINUE THEIR SUBSCRIPTION.

General Terms
