- 5.3.3 Customer shall be able to purchase the Add Ons via Boost application (“**Partner Channels**”).
- 5.3.4 This Add Ons shall be available for purchase while in Malaysia or abroad and offered in partnership with selected Network Operators in selected countries only (the “**Participating Countries**”).
- 5.3.5 Customer shall receive an SMS notification from Celcom or Digi upon successful subscription. Celcom or Digi sender code is 29000MYCD.
- 5.3.6 This Add-Ons shall be automatically activated upon the first usage in Participating Countries by using mobile data.
- 5.3.7 Customer shall ensure that the Add Ons is activated based on the Participating Countries within 30 days from the purchase date to enjoy the entitlement. Any entitlements not activated within this timeframe shall be forfeited.
- 5.3.8 Customer shall monitor and manage the Add Ons and usage via CelcomDigi App or USSD menu *800# (while in overseas).
- 5.3.9 Roaming voice calls in the Add Ons is only applicable for roaming voice calls made by

the Customer from the Participating Countries (calls are based on 60 seconds block):

- 5.3.9.1 To any Malaysian number;
- 5.3.9.2 To any number within present roaming country; and
- 5.3.9.3 Receiving calls while Customer is in the Participating Countries.

5.3.10 Any call and SMS shall follow the standard international roaming rates as stated on [CelcomDigi website](#).

5.3.11 Multiple subscriptions: Customers shall not be able to purchase more than one Add Ons at any point of time. Any existing Add Ons shall be unsubscribed and the remaining validity and quota balance (if any) shall be forfeited upon the purchase of a new Add Ons.

General Terms
