The full terms and conditions of the use of the selected products and/or services are as set out at [CelcomDigi website](#) ("**General Terms**"), including CelcomDigi Privacy Notice as set out at [CelcomDigi Privacy Notice](#) all of which form an integral part of full terms and conditions of the said products and/or services (collectively, the "**Terms and Conditions**").

All terms and references used herein shall be the same as the General Terms unless otherwise defined. In the event there is a conflict or inconsistency between these Terms and Conditions and the General Terms, the Terms and Conditions herein shall take precedence.

1. Each Customer (as defined below) acknowledges that they have carefully read, fully understood, and expressly agree to be legally bound by the Terms and Conditions.  - 5.1. **Availability**

- 5.3.3.2. Offer 3 shall be purchased through CelcomDigi App, CelcomDigi website, or by walk-in at any CelcomDigi physical retail or franchise outlets.
- 5.3.3.3. By subscribing to Offer 3, Customer shall be charged a fixed monthly Subscription Fee throughout a 12-month contract period ("**Term**"), starting from the date of successful sooka subscription.
- 5.3.3.4. Offer 3 is available only to Customers who do not have an existing active contract on the same Mobile Station International Subscriber Directory Number ("**MSISDN**") since each MSISDN may have only one (1) active contract with CelcomDigi at a time.
- 5.3.3.5. An early termination fee shall apply in the event of contract termination before expiry. The early termination fee shall be calculated as Recommended Retail Price (RRP) × Remaining contract months.

Example: If there are five (5) months remaining in contract, the early termination fee is calculated as: RM47.10 (RRP) × 5 months = RM235.50.
- 5.3.3.6. Upon termination, Offer 3 subscription shall be cancelled immediately.

Other Terms and Conditions

- i. Customers shall maintain an active Celcom or Digi line to subscribe to the Add-Ons. For clarity, active means the Customers shall be able to make and return calls.
- ii. The Add-Ons are not available to Customers with any outstanding bills and/or if their line is suspended or deactivated by CelcomDigi.
- iii. The Customers' Subscriptions shall be renewed according to their validity. CelcomDigi shall send an SMS notification upon successful renewal. However, CelcomDigi does not guarantee the timeliness of the Subscription renewal and shall not bear responsibility for any damages incurred directly or indirectly due to a delayed or failed renewal within the stipulated renewal window as stated in this clause.
- iv. If the renewal fails for any reason whatsoever, CelcomDigi will send notification via SMS to the Customer to inform the Customer of the failure. Failure of renewal may be due to inter alia either insufficient credit in the Customer's main credit balance OR the Customer is currently in inactive status due to validity. However, CelcomDigi shall not bear responsibility for any damages incurred directly or indirectly due to or consequences of

failure to send out the SMS notification within the stipulated renewal window as stated in this clause.

- v. The Add-Ons are on auto-renewed subscription. THE CUSTOMERS MUST TERMINATE THEIR SUBSCRIPTION IF THEY WISH TO DISCONTINUE THEIR SUBSCRIPTION.

General Terms

1. CelcomDigi shall not be responsible in any way in the event that the Customer's subscription is activated by a 3rd party without their consent. CelcomDigi shall not refund nor compensate the Customer in any manner whatsoever in such situations.
2. CelcomDigi does not guarantee or warrant that there shall be no problem, defect or error in the access or usage provided by this Subscription. CelcomDigi shall not be responsible in any way whatsoever for the loss incurred directly or indirectly for such failure or any problems associated with the network in any way whatsoever.
3. CelcomDigi reserves its absolute right and discretion to apply the Fair Usage Policy if the Customer is suspected to have had abused the services or internet usage in whatsoever way including exceeding the base quota.
4. CelcomDigi shall not be liable in any manner whatsoever to any party for any claims, proceedings, loss, damage, costs, or expenses of any kind whatsoever suffered or incurred as a direct or indirect result of the utilisation of the Products and Services by the Customer.
5. CelcomDigi shall not be liable in any manner whatsoever to the Customers for any claims, proceedings, loss, damage, costs or expenses of any kind whatsoever suffered or incurred as a direct or indirect result of the utilisation of the Products and Services.
