

Samsung Galaxy Z Flip8 and Fold8 5G Phones Launch (“Campaign”)

This Campaign is organised by CelcomDigi Mobile Sdn. Bhd. (Company No. 197601002188 (27910-A)) (“**Celcom**”) and CelcomDigi Telecommunications Sdn. Bhd. (Company. No. 199001009711 (201283-M)) (“**Digi**”)

(Celcom and Digi are collectively known as “**CelcomDigi**” for the purpose of this Campaign.)

This Campaign will be governed by these terms and conditions and any subsequent accompanying campaign details (if any), CelcomDigi’s Privacy Notice, Data Protection Statement and Data Protection Obligations found on CelcomDigi’s website at [CelcomDigi Privacy Notice](#) (collectively referred to as the “**Terms**”). Each Eligible Participant (as defined below) agrees that he/she has read and understood the Terms and by his or her participation in this Campaign, each Eligible Participant agrees to be bound by the Terms.

1. Campaign Period

- 1.1. This Campaign commences at 10.00 a.m. on 14 August 2026 until further notice (“**Campaign Period**”). CelcomDigi has the sole and absolute discretion to extend and/or vary the Campaign Period without prior notification.

- 3.5.2 Eligible Participant shall receive a voucher code from CelcomDigi via WhatsApp (016-333 8888) within three (3) working days from the device purchase date. Eligible Participant shall follow the instructions provided in the WhatsApp message to redeem the Samsung 55" UHD 4K Smart TV 2026.
- 3.5.3 The Samsung 55" UHD 4K Smart TV 2026 shall be delivered within thirty (30) working days from the date of completion for Clause 3.5.2.
- 3.5.4 Risk in the Samsung 55" UHD 4K Smart TV 2026 shall pass to the Eligible Participant upon successful delivery and acceptance. The Eligible Participant (or authorised representative) is responsible for inspecting the Samsung 55" UHD 4K Smart TV 2026 upon delivery.
- 3.5.5 In the event the Samsung 55" UHD 4K Smart TV 2026 is found to be defective at the point of delivery and such defects are identified and reported to the delivery personnel, the delivery partner shall arrange for a replacement. Such replacement shall follow a new fulfilment process as set out herein.
- 3.5.6 In the event the Samsung 55" UHD 4K Smart TV 2026 is found to be defective after acceptance of the delivery, the Eligible Participant shall contact Samsung Customer Care directly to claim from the applicable manufacturer's warranty, which is valid

3.6. Trade-In Bonus: RM100 Credit to Bill

3.6.1. Eligible Participants shall be required to complete his/her trade-in by 31 August 2026 to retain the estimated Trade-In Value. Any Trade-In after this date shall subject to the prevailing Trade-In Value at the time of device assessment. The final Trade-In Value shall subject to successful device diagnostics and inspection during the device assessment.

9. By participating in this Campaign, each Eligible Participant agrees and irrevocably and unconditionally undertakes to fully absolve CelcomDigi of all liabilities and agrees to

indemnify CelcomDigi (on full indemnity basis) and hold CelcomDigi harmless against any claim by any third party and against any loss, damage, cost or expense (including solicitors' fees and cost) that CelcomDigi may suffer or incur as a result of or in connection with this Campaign.

10. A failure by CelcomDigi to enforce any of these Terms in any instance(s) will not give rise to any claim by any person.
11. By participating in this Campaign, each Eligible Participant agrees to be bound by these Terms and CelcomDigi's decision is final and binding and no correspondences shall be entertained.
12. These Terms shall be governed and construed by the laws of Malaysia and the parties shall submit to the exclusive jurisdiction of the Courts of Malaysia.
13. All other terms and conditions governing the use of any of CelcomDigi mobile telecommunication services shall apply herein mutatis mutandis.
