

CelcomDigi Mega Gegar 20 Juta Contest ("Contest")

This Contest is held by CelcomDigi Mobile Sdn. Bhd. (Company No. 197601002188 (27910-A)) ("**Celcom**") and CelcomDigi Telecommunications Sdn. Bhd. (Company. No. 199001009711 (201283-M)) ("**Digi**") (Celcom and Digi are collectively known as "**CelcomDigi**" for the purpose of this Contest.)

This Contest will be governed by these terms and conditions and any subsequent accompanying contest details (if any), CelcomDigi's Privacy Notice, Data Protection Statement and Data Protection Obligations found on CelcomDigi's website at [CelcomDigi Privacy Notice](#) (collectively referred to as the "**Terms**"). Each Eligible Participant (as defined below) agrees that he/she has read and understood the Terms and by his or her participation in this Contest, each Eligible Participant agrees to be bound by the Terms.

The Contest is conducted in conjunction with the CelcomDigi Mega Gegar 20 Juta Nationwide Sale and shall be governed by these Contest Terms and Conditions together with the CelcomDigi Mega Gegar 20 Juta Nationwide Sale Terms and Conditions. Completion of a Qualifying Transaction under the CelcomDigi Mega Gegar 20 Juta Nationwide Sale does not automatically entitle a customer to win a Prize. Completion of a Qualifying Transaction only renders the customer eligible to participate in this Contest, subject to compliance with the Contest Terms and Conditions and the satisfaction of all eligibility requirements. All matters relating to Contest eligibility, participation mechanics, winner selection, verification, Prize allocation and fulfilment and any other Contest related matters shall be governed exclusively by these Contest Terms and Conditions.

1. **Contest Period**

- 1.1. This Contest commences at 12.00 a.m. on the 23 July 2026 and runs until 11.59 p.m. on the 30 September 2026 (both dates inclusive) ("**Contest Period**"). Any transaction received after the Contest Period will be automatically disqualified. CelcomDigi has the sole and absolute discretion to extend and/or vary the Contest Period without prior notification.

2. **Eligibility Criteria**

- 2.1. All Malaysian CelcomDigi subscribers who are 18 years of age and above, lawfully residing in Malaysia and who, successfully complete at least one (1) Qualifying Transaction during the Contest Period in accordance with these Terms shall be

eligible to participate in this Contest (“**Eligible Participants**”) except for the following: -

- 2.1.1. corporate and corporate individual subscribers; or
- 2.1.2. subscribers who have any overdue and unpaid amounts owing to CelcomDigi; or
- 2.1.3. subscribers whose accounts or lines are suspended, barred, restricted, terminated, cancelled, disconnected, inactive, expired or otherwise not in active service; or
- 2.1.4. subscribers who have breached [any applicable CelcomDigi Terms and Conditions](#) or are otherwise determined by CelcomDigi, in its sole discretion, to be ineligible under these Terms;
- 2.1.5. permanent, contract and temporary employees of CelcomDigi and their Immediate Family Members; and
- 2.1.6. employees of CelcomDigi’s partners, advertising agencies, promotion agencies and any other persons involved in the organization, promotion and/or the conduct of this Contest together with their Immediate Family Members.

For the purpose of these Terms, “Immediate Family Members” shall mean a spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

- 2.2. Each Eligible Participant confirms that he/she has read, and understood the Terms and by his or her participation in this Contest:-
 - 2.2.1. agrees to be bound by the Terms; and
 - 2.2.2. represents and warrants that all information submitted to CelcomDigi in connection with this Contest is true, accurate and complete.
- 2.3. All personal details submitted must be accurate and complete and are subject to verification by CelcomDigi upon request.
- 2.4. CelcomDigi reserves the right, at any time, to verify the validity of entries and participants and to disqualify any participant or entry that does not comply with these Terms or that tampers with the entry process. Incomplete, indecipherable,

illegible, inaccurate, misleading or fraudulent entries or any entry which does not comply with the Terms will be automatically disqualified without any prior notice.

3. Contest Mechanics

3.1. The Contest shall be conducted over five (5) cycles (each, a “Cycle”) during the Contest Period:

Important notes:

- *Eligible Participants shall complete an eligible transaction within each Qualifying Transaction Period to participate in the above Cycles. Multiple qualifying transactions within the Qualifying Transaction Period shall not provide any additional advantage or allow Eligible Participants to participate more than once.*

3.2. For the purposes of this Contest, the following transactions shall constitute (“Qualifying Transactions”) during the Contest Period:

- 3.2.1. Purchase of any offers from the CelcomDigi Mega Gegar 20 Juta Nationwide Sale as outlined in the [CelcomDigi Mega Gegar 20 Juta Nationwide Sale Terms and Conditions](#); or
- 3.2.2. **CelcomDigi Prepaid** – Any successful new registration, Mobile Number Portability or plan upgrade to an eligible Prepaid Mobile Internet offer with a minimum transaction value of RM30; or
- 3.2.3. **CelcomDigi Postpaid & CelcomDigi One** – Any successful new registration, Mobile Number Portability, conversion from Prepaid to Postpaid or plan upgrade to an eligible CelcomDigi Postpaid 5G 2026 or CelcomDigi One 2026 plans with a minimum monthly commitment fee of RM50; or

- 3.2.4. **Device & Service Contract** – Any successful new subscription or activation of the Easy360 Device Contract, Pakej MegaJimat Device Contract, Freedom Add-Ons, Mega Add-Ons; or
- 3.2.5. **Other Service Add-Ons & Value-Added Services** – Any successful new purchase(s) of Quota Top Up, One-Time Roaming Pass, Entertainment, Security, PhoneCARE or PhoneFIX subscriptions with a minimum transaction value of RM20.
- 3.2.6. For the avoidance of doubt, any subscription renewal, auto-renewal or recurring subscription are excluded and shall not be considered a Qualifying Transaction.
- 3.3. Only Qualifying Transactions that are successfully completed, activated and accepted by CelcomDigi during the Contest Period shall be eligible for participation.
- 3.4. For the avoidance of doubt, transactions completed outside the Contest Period, or which are subsequently cancelled, refunded, reversed, terminated or otherwise deemed invalid shall not constitute Qualifying Transactions and shall be disqualified from the Contest.
- 3.5. CelcomDigi reserves the sole and absolute discretion to determine the eligibility and validity of any Qualifying Transaction.
- 3.6. In order to participate in this Contest, the Eligible Participants shall carry out the following steps within the Contest Period:-
 - Step 1** : To successfully complete at least one (1) Qualifying Transaction during the Contest Period.
 - Step 2** : To download, install and sign in to the CelcomDigi App using the MSISDN which is associated with the Qualifying Transaction.
 - Step 3** : To make sure there are no overdue and unpaid amounts owing to CelcomDigi.
 - Step 4** : To correctly answer the qualifying question(s) made available in the CelcomDigi App within the stipulated response window as determined by CelcomDigi.
- 3.7. **Notification to Eligible Participants**
 - 3.7.1. Eligible Participants shall receive an SMS notification from **22228MYCD** one (1) day before the applicable Contest Cycle Date.

- 3.7.2. The SMS notification shall include:
 - 3.7.2.1. instructions to answer qualifying question(s) on the applicable Contest Cycle Date;
 - 3.7.2.2. designated time slot ("**Drop**") to answer the qualifying question(s).
 - 3.7.3. Eligible Participants shall submit their complete response within the stipulated response window on the applicable Cycle Date as stated in Table 1, or by such other deadline as specified in the SMS notification. Any responses received after the Drop shall not be considered.
 - 3.7.4. Each Eligible Participant shall only be entitled to participate in one (1) Drop within the applicable Cycle Date as assigned by CelcomDigi. Each Eligible Participant shall not be permitted to participate in any other Drop within the same Cycle Date.
4. **Selection and Notification of Contest Winners**
- 4.1. Selection of Potential Winners and Contest Winners for each Cycle will be based on the following process. For purposes of this Contest, Potential Winners shall mean Eligible Participants who have been selected based on the Contest Mechanics, including the submission of a complete and correct response to the qualifying question(s) within the stipulated response window and whose ranking qualifies them for consideration for a Prize in the relevant contest Cycle. A Potential Winner shall not be deemed a Contest Winner and shall have no entitlement to any Prize unless and until CelcomDigi has completed all verification checks and confirmed that such Potential Winner has satisfied all eligibility requirements and complied with these Terms ("**Potential Winners**").  - 4.1.1. Eligible Participants who correctly answer the qualifying question(s) on the applicable Cycle Date within the stipulated response window, shall be ranked separately within their respective groups as set out in Clause 3.7, based on the time CelcomDigi receives their complete and correct response, with the earliest valid response ranking first.

- 4.1.3.  - 4.1.4. In the event of identical submission timestamps, system anomalies, technical issues or any other circumstances affecting the determination of response order, CelcomDigi reserves the right to determine the successful Potential Winners at its sole discretion acting reasonably and in accordance with its system records.
 - 4.1.5. Following the completion of the Prize allocation under Clause 4.1.3, each Eligible Participant shall be invited to open a Mystery Box via the CelcomDigi App. Where a Prize has been allocated under Clause 4.1.3, the Mystery Box shall reveal the Prize allocated to the relevant Potential Winner. Where no Prize has been allocated, the Mystery Box shall indicate that no Prize has been awarded for the applicable contest Cycle. For the avoidance of doubt, the Mystery Box does not determine, allocate, modify or otherwise affect the Prize allocated to the Potential Winner under Clause 4.1.3.
 - 4.1.6. CelcomDigi's determination of the ranking, verification, selection of Contest Winners and allocation of Prizes shall be final, conclusive and binding. No correspondence, appeals or disputes will be entertained.
- 4.2. Verification and confirmation of Contest Winners:
- 4.2.1. A Potential Winner shall not be deemed a Contest Winner unless and until CelcomDigi has verified that the Potential Winner has satisfied all eligibility requirements and complied with these Terms.
 - 4.2.2. Following the completion of the verification process, each Potential Winner shall, within seven (7) working days, acknowledge receipt of the Prize notification and provide all information and supporting documents required by CelcomDigi for the purposes of verification, prize acceptance and prize fulfilment including but not limited to the Potential Winner's full name, identification details, contact number and preferred delivery address.

4.2.3. If a Potential Winner is found to be ineligible, fails the verification process, fails to comply with these Terms, fails to provide the required information within seven (7) working days or declines the Prize for any reason, CelcomDigi reserves the right, at its sole discretion to:

4.2.3.1. forfeit the Prize without further notice; or

CelcomDigi shall have no obligation to select a replacement winner or award the Prize to any other person.

5.3.1.2. Any manufacturer's warranty, after-sales service or product-related claims shall be governed solely by [Samsung's applicable terms and conditions](#).

5.3.2. 1 Year Free Roaming - Unlimited Worldwide Pass worth a total of RM2,124,000

5.3.2.1. One thousand five hundred (1,500) winners will be selected under the Contest to receive twelve (12) months of complimentary 30-Day Unlimited High Speed Worldwide Roam Pass ("**Free Roam Pass**"). The Free Roam Pass will be automatically renewed on a monthly basis for twelve (12) consecutive months from the date of activation.

5.3.2.2. The Free Roam Pass provides Unlimited high-speed roaming data for eligible destinations, with the same country coverage as the CelcomDigi Prepaid 30-Day Worldwide Roam Pass (RM118), subject to the prevailing [CelcomDigi Roam Pass Terms and Conditions](#).

5.3.2.3. The Free Roam Pass will be credited and activated on the Contest Winner's eligible CelcomDigi account after the winner announcement. No manual activation is required.

5.3.2.4. To use the Free Roam Pass, the Contest Winner shall enable Data Roaming on his/her device upon arrival at an eligible roaming destination.  - 5.3.3.1. Seventy thousand (70,000) winners will be selected under the Contest to receive twelve (12) months of complimentary 15GB (5G+4G) High Speed Internet ("**Free Internet**").
 - 5.3.3.2. The Free Internet can only be used in conjunction with an active subscription to any of the eligible prepaid monthly Internet passes postpaid plans. The Free Internet will remain available only while the eligible pass is active and valid.
 - 5.3.3.3. Upon the expiry, termination or deactivation of the eligible monthly Internet pass, any remaining quota under the Free Internet will also become unavailable and will not be accessible.
 - 5.3.3.4. The Free Internet provides 15GB of high-speed Internet data for all usage within Malaysia, subject to the main plan or monthly internet pass validity period and prevailing [CelcomDigi Terms and Conditions](#).
 - 5.3.3.5. The Free Internet will be credited and activated on the Contest Winner's eligible and active CelcomDigi MSISDN after the winners' announcement. No manual activation is required.
 - 5.3.3.6. All Fibre Standalone and 5G Home WiFi subscribers shall have a corresponding CelcomDigi MSISDN to be eligible for the Free Internet.
 - 5.3.3.7. The Free Internet is subject to CelcomDigi's Fair Usage Policy, Celcom's Fair Usage Policy and Digi's Fair Usage Policy.
- 5.3.4. **1 Year Free Entertainment Subscription - sooka Entertainment worth a total of RM143,000**

- 5.3.4.1. One thousand (1,000) winners will be selected under the Contest to receive one (1) complimentary twelve (12)-month sooka Entertainment subscription ("**Free sooka Subscription**"), subject to these Terms and Conditions.
- 5.3.4.2. The Free sooka Subscription will be fulfilled via backend provisioning to the Contest Winner's eligible and active CelcomDigi MSISDN in October 2026 (or such other date as determined by CelcomDigi). Contest Winners will be notified via SMS upon successful provisioning and activation of the Free sooka Subscription.
- 5.3.4.3. The Free sooka Subscription shall be provisioned on a one-time basis and shall remain valid for twelve (12) consecutive months from the date of successful activation. Upon expiry of the twelve (12)-month validity period, the Free sooka Subscription shall automatically terminate and will not auto-renew. The Free sooka Subscription is non-transferable, non-exchangeable, non-refundable and not redeemable for cash, credit or any other form of compensation. - 5.3.4.4. A Potential Winner who has an active subscription to any of the sooka subscriptions listed in Clause 5.3.4.3 shall remain a valid Contest Winner. However, the Free sooka Subscription shall only be provisioned if the winner satisfies the fulfilment eligibility requirements within the fulfilment timeline determined by CelcomDigi.
 - 5.3.4.5. If a Potential Winner does not satisfy the fulfilment eligibility requirements within the fulfilment timeline determined by CelcomDigi, the Free sooka Subscription shall be deemed forfeited. No cash payment, bill rebate, replacement subscription or any other form of compensation shall be provided.

CelcomDigi reserves the right to verify a Potential Winner's eligibility, subscription status and compliance with these Terms prior to and/or at the time of provisioning the Free sooka Subscription. CelcomDigi's decision on all matters relating to winner verification, fulfilment and eligibility shall be final and binding.
- 5.3.5. **1 Year Free Security Services- MobileSHIELD 1-Device 12-Month Subscription worth a total RM120,000**
- 5.3.5.1. One thousand (1,000) Contest Winners selected under the Contest will receive one (1) complimentary 12-month MobileSHIELD 1-Device subscription ("**Offer**"). The Offer will be fulfilled via backend provisioning to the Contest Winners' eligible and active CelcomDigi MSISDNs in October 2026 (or such other date as determined by CelcomDigi). Contest Winners will receive an SMS notification upon successful fulfilment and activation of the Offer.
 - 5.3.5.2. The Offer shall be provisioned on a one-time basis and shall remain valid for twelve (12) consecutive months from the date of successful activation. The Offer is non-transferable, non-exchangeable, non-refundable and not redeemable for cash. Upon expiry of the twelve (12)-month validity period, the Offer will automatically terminate and will not auto-renew.
