

StreamMORE Bundles (“Add Ons”)

StreamMORE Bundles are bundled Subscription services made available by CelcomDigi to its customers, offering access to selected streaming services together with Internet quota, subject to the applicable bundle as subscribed by the Customer.

This Add Ons shall include streaming services as provided by the streaming service providers, including but not limited to iQIYI, Viu, Vision+, Disney+, sooka and Prime Video (“**Streaming Partners**”).

The full terms and conditions of the use of the selected products and/or services are as set out at [CelcomDigi website](#) (“**General Terms**”), including the Privacy Notice as set out at [CelcomDigi Privacy Notice](#); all of which form an integral part of full terms and conditions of the said products and/or services (collectively, the “**Terms and Conditions**”).

All terms and references used herein shall be the same as the General Terms unless otherwise defined. In the event there is a conflict or inconsistency between these terms and conditions and the General Terms, the terms and conditions herein shall take precedence.

1. Each Customer (as defined below) agrees that he/she has read and understood the Terms and Conditions and by his or her purchasing/subscribing to the Add Ons, each subscriber agrees to be bound by the Terms and Conditions. Furthermore, by subscribing to the Add-Ons, each Customer further agrees and confirms that he/she has read, understood, accepted and agreed to be bound by the Terms and Conditions, and Privacy Policy of each Streaming Partner. The Customer’s use of the Add-Ons constitutes acceptance of all terms set forth therein.

3. CelcomDigi reserve the right to revise, modify and/or change these terms and conditions at any time at CelcomDigi’s sole discretion without providing notice to Customers. Continued use of this Add Ons service following any changes to these terms and conditions constitutes an acceptance to those changes (if any). 5. Add Ons

5.1. Availability

5.1.1. This Add Ons shall commence from 28 May 2026 except;

- a) StreamMORE Asian Weekly Bundle and StreamMORE Premium Bundle shall commence on 24 September 2026.

5.1.2. Any changes or discontinuation thereof shall be at the sole discretion of CelcomDigi.

5.1.3. This Add Ons shall be available for purchase through CelcomDigi App, CelcomDigi website, or by walk-in to any [CelcomDigi's physical retail outlets](#) or CelcomDigi's franchise outlets.

5.2. Eligibility

5.2.1. The Add Ons shall be applicable to all eligible CelcomDigi Postpaid and Prepaid customers unless expressly excluded (herein defined as "**Customer**").

5.2.2. The Add Ons shall not be applicable to:

- Customer who has an existing access to the same or similar streaming service(s) under his/her existing CelcomDigi Plan or subscription; and/or
- Any other Subscription as may be determined by CelcomDigi from time to time.

However, upon successful Subscription of StreamMORE Premium Bundle, the existing overlapping Subscription, including all associated entitlements, access, and benefits, shall be terminated and replaced by the new bundle. No refund, prorated, or carry-forward of the remaining Subscription period shall be entertained.

5.4. Other Terms and Conditions

5.4.1. Customers shall be able to subscribe to more than one StreamMORE bundle, subject to no overlapping of streaming services within the Subscriptions.

- 5.4.2. In the event the Customer subscribes to another StreamMORE bundle or Subscription with an overlapping streaming service, the Customer's existing overlapping Subscription shall be terminated and replaced immediately upon successful Subscription of the new bundle.
- 5.4.3. Any unused entitlement, validity period, bundled quota, unlimited quota, streaming service access or Subscription benefits from the existing overlapping Subscription shall be forfeited immediately upon replacement. No refund, rebate or proration shall be entertained.
- 5.4.4. Streaming services included under the respective Add Ons shall not be able to subscribe on its own, managed, terminated or cancelled individually. The Add Ons shall only be managed as part of the bundled Subscription.
- 5.4.5. Activation of the respective streaming services shall require the Customers to complete account registration, activation or login through the respective streaming service platforms.
- 5.4.6. Access, streaming quality, concurrent streaming limit, device compatibility and available streaming content shall vary depending on the respective streaming service entitlement provided by the respective Streaming Partners.
- 5.4.7. The Subscription shall not be able to transfer to any other mobile number.
- 5.4.8. The Customers' Subscriptions shall be renewed according to its validity period. CelcomDigi shall send an SMS notification upon successful renewal. However, CelcomDigi does not guarantee the timeliness of the Subscription renewal and shall not bear responsibility for any damages incurred directly or indirectly due to delayed or failed renewal.
- 5.4.9. If the renewal fails for any reason whatsoever, CelcomDigi shall send notification via SMS to the Customer to inform the Customer of the failure.
- 5.4.10. Failure of renewal may be due to insufficient credit limit, suspended line status, inactive account status or any other reason as determined by CelcomDigi.
- 5.4.11. The Add Ons are on auto-renewed Subscription, except where expressly stated otherwise. THE CUSTOMERS MUST TERMINATE THEIR SUBSCRIPTION IF THEY WISH TO DISCONTINUE THEIR SUBSCRIPTION.

4. CelcomDigi reserves its absolute right and discretion to apply the Fair Usage Policy if the Customer is suspected to have had abused the services or internet usage in whatsoever way including exceeding the base quota.
5. CelcomDigi shall not be liable in any manner whatsoever to any party for any claims, proceedings, loss, damage, costs, or expenses of any kind whatsoever suffered or incurred as a direct or indirect result of the utilisation of the Products and Services by the Customer.
