MODERATE STRATEGY

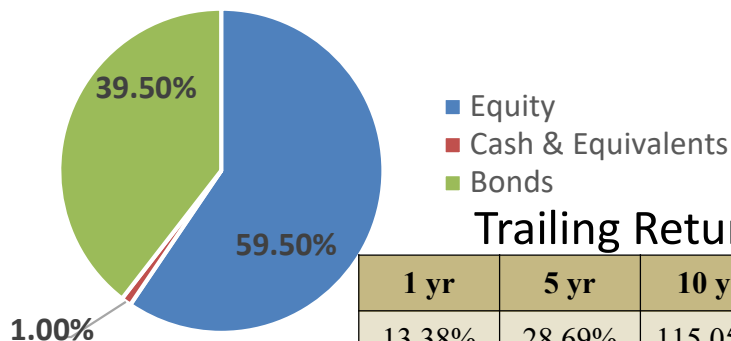
The PVG Moderate Strategy will generally own approximately 60% of the portfolio in stocks and equity ETFs and 40% in bond ETFs, or equities that have high yields like a bond. This allocation is for a moderate-risk investor and is considered a balanced allocation. The allocation in equities can range from 0% to approximately 70% and bonds from 0% to 100% under unusual circumstances. The theory, bonds will protect the downside in a bear market, but sometimes this does not occur, as a result the portfolio has the latitude to use cash or other defensive securities. The equity holdings will generally be well diversified in large-cap, mid-cap small-cap, and international equities but has the latitude to be very flexible. The bond holdings will also be generally well diversified in both government and corporate bond ETFs, but as well can be very flexible. Alternatives may be implemented into the portfolio. The goal of the strategy is to also provide an attractive stream of income.
