

DATA PRIVACY FRAMEWORK POLICY

Updated July 24, 2025

The Plasma Protein Therapeutics Association, 147 Old Solomons Island Road, Suite 100, Annapolis, MD, 21401 ("PPTA") complies with the EU-U.S. Data Privacy Framework ("EU-U.S. DPF"), the UK Extension to the EU-U.S. DPF, and the Swiss-U.S. Data Privacy Framework ("Swiss-U.S. DPF") as set forth by the U.S. Department of Commerce (collectively, the "DPF").

PPTA has certified to the U.S. Department of Commerce that it adheres to the EU-U.S. Data Privacy Framework Principles ("EU-U.S. DPF Principles") with regard to the processing of personal data received from the European Union in reliance on the EU-U.S. DPF and from the United Kingdom (and Gibraltar) in reliance on the UK Extension to the EU-U.S. DPF. The Company has certified to the U.S. Department of Commerce that it adheres to the Swiss-U.S. Data Privacy Framework Principles ("Swiss-U.S. DPF Principles") with regard to the processing of personal data received from Switzerland in reliance on the Swiss-U.S. DPF.

If there is any conflict between the terms in this Data Privacy Framework Policy ("Policy") and the EU-U.S. DPF Principles, the UK Extension to the EU-U.S. DPF Principles, and/or the Swiss-U.S. DPF Principles, the Principles shall govern. Definitions

"Data Subject" means the individual to whom any given Personal Data covered by this Policy refers.

"Personal Data" means any information relating to an individual in the European Union, United Kingdom, and Switzerland that can be used to identify that individual either on its own or in combination with other readily available data.

"Sensitive Personal Data" means Personal Data regarding an individual's racial or ethnic origin, political opinions, religious or philosophical beliefs, trade-union membership, physical or mental health, or sexual life.

Scope and Responsibility

This Policy applies to Personal Data transferred from European Union member countries, the United Kingdom, and Switzerland to PPTA's operations in the U.S. in reliance on the DPF and does not apply to Personal Data transferred under standard contractual clauses or binding corporate rules.

All employees of PPTA that have access in the U.S. to Personal Data covered by this Policy are responsible for conducting themselves in accordance with this Policy. PPTA employees responsible for engaging third parties to which Personal Data covered by this Policy will be transferred (e.g., consultants assisting with the development of voluntary industry standards, as well health-related investigations and analyses, to protect the health of plasma donors

and the safety of plasma protein therapies) are responsible for obtaining appropriate assurances that such third parties have an obligation to conduct themselves in accordance with the applicable provisions of the DPF and this Policy.

Collection and Use of Personal Data

PPTA may collect and process Personal Data as follows:

- When you visit the PPTA website, your Personal Data may be processed in accordance with the **Privacy Policy** available on our website.
- If you are an employee of PPTA, your Personal Data may be processed in accordance with the **Belgium Data Protection Notice for Employees**.
- If you are a contractor of PPTA, your Personal Data may be processed for payment-related purposes, including your name, address, contact information (*i.e.*, email address and phone number), financial/payment account details, or other information contained within an invoice.
- We may process other categories of Personal Data as described to you at the point of data collection, with your consent, or where required by applicable law.

Disclosure of Personal Data

We may disclose Personal Data that we collect to the following categories of recipients:

- Our Service Providers. We disclose your Personal Data to our service providers that provide business, professional, or technical support services to us, help us operate our business and offer our services, or administer activities on our behalf.
- Our Research Partners. We disclose your Personal Data to our research partners, including those that administer surveys or conduct research projects in partnership with us or on our behalf.

In certain circumstances, we may disclose your Personal Data to:

- Competent Governmental, Regulatory, and Public Authorities. We may disclose your Personal Data to government and law enforcement authorities, in each case to comply with legal or regulatory obligations or requests, including to meet national security or law enforcement requirements or as is otherwise described in this Policy.
- Relevant Third Parties as Part of a Corporate Transaction. In the event of a reorganization, merger, sale, joint venture, assignment, transfer, or other disposition of all or any portion of our business, assets, or stock (including in connection with a bankruptcy or similar proceeding), we may disclose or transfer your Personal Data to certain third parties, such as the acquiring entity and its advisers.
- Other Third Parties. We will disclose your Personal Data to other third parties at your direction or with your consent. Additionally, we will disclose your Personal Data as we believe necessary or appropriate to: (a) comply with applicable law; (b) enforce our terms and conditions; (c) protect our operations; (d) protect our rights, privacy, safety, or property, and/or those of you or others; and (e) allow us to pursue available remedies or limit damages that we may sustain.

We may disclose your Personal Data for other reasons that we will describe at the time of

information collection or prior to disclosing your information.

PPTA remains liable under the EU-U.S. DPF Principles, the UK Extension to the EU-U.S. Principles, and Swiss-U.S. DPF Principles if an agent processes Personal Data covered by this Policy in a manner inconsistent with the Principles, except where PPTA is not responsible for the event giving rise to the damage.

Your Choices

The DPF provides that when Personal Data covered by this Policy is to be used for a new purpose that is materially different from that for which the Personal Data was originally collected or subsequently authorized, or is to be disclosed to a non-agent third party, Data Subjects have an opportunity to choose whether to have their Personal Data so used or disclosed. Further, if Sensitive Personal Data covered by this Policy is to be used for a new purpose that is different from that for which the Sensitive Personal Data was originally collected or subsequently authorized or is to be disclosed to a non-agent third party, PPTA Data Subjects must offer explicit consent prior to such use or disclosure.

PPTA will notify you whether your consent is required for any use or disclosure of Sensitive Personal Data. Otherwise, to exercise your choices in accordance with this Policy, please contact PPTA using this link: [Contact Us - PPTA](#).

Access

Data Subjects whose Personal Data is covered by this Policy have the right to access such Personal Data and to correct, amend, or delete such Personal Data if it is inaccurate or has been processed in violation of the EU-U.S. DPF Principles, the UK Extension to the EU-U.S. Principles, and Swiss-U.S. DPF Principles (except when the burden or expense of providing access, correction, amendment, or deletion would be disproportionate to the risks to the Data Subject's privacy, or where the rights of persons other than the Data Subject would be violated). Recourse, Enforcement, and Liability

PPTA's participation in the DPF is subject to investigation and enforcement by the Federal Trade Commission.

PPTA commits to resolve complaints about your privacy and our collection or use of your Personal Data transferred to the United States pursuant to the DPF. Residents of the EEA, UK, or Switzerland with inquiries or complaints should first contact PPTA at: [Contact Us - PPTA](#).

PPTA has further committed to refer unresolved privacy complaints to an independent dispute resolution mechanism operated by the International Centre for Dispute Resolution (ICDR-AAA). If you do not receive timely acknowledgment of your complaint by PPTA, or if your complaint is not satisfactorily addressed by PPTA, please visit https://go.adr.org/dpf_irm.html for more information and to file a complaint. This service is

provided free of charge to you.

If you have a complaint involving employee Personal Data as described above, you may contact the Data Protection Authority (DPA) in your country. If you are a resident of the United Kingdom, please contact the UK Information Commissioner's Office (ICO) at <https://ico.org.uk/make-a-complaint/>. If you are a resident of Switzerland, please contact the Swiss Federal Data Protection and Information Commissioner (FDPIC) at <https://www.edoeb.admin.ch/edoeb/en/home/deredoeb/kontakt.html>. The Company agrees to cooperate with the DPAs in the European Union, the United Kingdom, and Switzerland and comply with the advice of such authorities with regard to employee Personal Data.

If your complaint cannot be resolved through the above channels, under certain conditions, you may invoke binding arbitration for some residual claims not resolved by other redress mechanisms. Please see [Annex I](#) to the DPF for more information on conditions giving rise to binding arbitration.
