PURPOSE OF THIS SUMMARY: This is an important notice concerning the benefits provided by the Allied Building Inspectors Local 211 I.U.O.E. Welfare Fund (the “Plan”) and it is being sent to you as a Summary of Material Modification. It is a summary of changes the Board of Trustees have made to the Plan and it is intended to supplement the Summary Plan Description (“SPD”) previously provided to you. You should retain this summary with your copy of the SPD.

DESCRIPTION OF THE MODIFICATION: The Plan has been modified as of July 1, 2024 to update the definition of “Dependent”, as indicated below:

“Dependent” means the employee's legal spouse or domestic partner, and all lawful dependents, defined as the employee's:

- biological child(ren);
- legally adopted child(ren);
- stepchild(ren) (child of legally married spouse or domestic partner);
- child(ren) named in a Qualified Medical Child Support Order;
- child(ren) for whom a court of law has named the employee as legal guardian; and
- an unmarried, disabled child of any age who resides in the household of the employee and who was initially covered by the Plan prior to age 26 and who is totally disabled by a mental or physical impairment which makes the child incapable of engaging in any gainful employment provided medical evidence of such impairment is furnished to the fund within 31 days after the date such child attained age 26.

Coverage will terminate for dependent children (other than eligible disabled children) at the end of the month in which the child reaches age 26. Children under the age of 26 whose employment provides them with employer-sponsored healthcare insurance coverage through the dependent's employment and accepts the coverage, will not be covered.
