#### 4 First-aid measures

## 4.1 Description of first-aid measures

#### General notes

Do not leave affected person unattended. Remove victim out of the danger area. Keep affected person warm, still and covered. Take off immediately all contaminated clothing. Impairment of vision. Production of tissue damage in the eye. Conjunctivitis (pink eye). Localized redness, edema, pruritis and/or pain.

Rinse immediately carefully and thoroughly with eye shower or water. Treat symptomatically.

### **6 Accidental release measures**

## 6.1 Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel

## 7 Handling and storage

## 7.1 Precautions for safe handling

Vapors are heavier than air, spread along floors and form explosive mixtures with air. Vapors may form explosive mixtures with air.

## Advice on general occupational hygiene
