1 What is Multi Lucky PA?

This policy provides compensation and reimbursement in the event of injuries, disability or death caused solely by accident. The compensation for Death and Permanent Disablement will be increased by 10% up to 50% on each subsequent renewal if there is no claim made under the policy.

2 Know Your Coverage

3 Know Your Obligations

For this personal accident insurance policy, you must pay a premium of:	
Standard cover	RM330 (annually)
Additional Cover	N/A
Total premium you must pay is RM330	
You also have to pay the following fees and charges:	
Stamp duty	RM10
Commission (Only applies if the product is sold through an intermediary)	25% of premium or RM82.50
Service Tax	8% of premium or RM26.40

The applicability of stamp duty and service tax amount herein applied, or any other taxes are subjected to the prevailing laws of Malaysia.

4 Other Key Terms

- You must provide complete and accurate information in the proposal form.
- You must disclose all material facts you know or should know, including personal activities that may affect the risk profile.
- **Claims:** You must submit your claim with all the supporting information and documents to us and give full cooperation to us in accessing your claim.
- **Person Eligible:** Insured persons who aged between 18 to 65, with the policy renewable up to age 70. Plan 1 age eligibility is 13 years and above.
- **Cash Before Cover:** Full premium must be paid to us or our authorized intermediary before the effective date of the policy.
