## 1 What is Children Bundle?

Children Bundle is an optional rider under Gen PA ZenProtect. It provides compensation for bone fractures, covers accidental dental and travel expenses, and offers an education allowance in the event of death or permanent disablement of the insured person's parents or legal guardian, with all benefits payable only when resulting from an accident.

- You must notify us immediately in the case of death claims and bodily injury claims within 21 days of the accident.
- **Person Eligible:**
  - All Malaysians, permanent residents, work permit holders, pass holders, and they are legally residing in Malaysia.
  - Insured persons who aged between 18 to 65, with the policy renewable up to age 70.
  - Child who aged at least 30 days old to 18 years old, maximum up to 23 years old if a full-time student.
- **Cash Before Cover:** Full premium must be paid to us or our authorized intermediary before the effective date of the policy.

### ? Can I cancel my policy?

- Yes. You may cancel your policy at any time by giving a written notice to us. Upon cancellation, we will return the proportionate part of the premium in respect of the unexpired period of insurance provided no claim has been made.
