Liability Release and Express Assumption of Risk Agreement

I _____ desire to participate in a series of speed trials in Bolivia South America to set a land speed record. **I UNDERSTAND THESE ATTEMPTS CAN BE DANGEROUS AND INVOLVE THE RISKS OF INJURY AND DEATH.** I understand these risks and voluntarily choose to participate in the event. I will be solely responsible for examining the racecourse conditions, safety personal and medical personal available before making any speed record attempts. I further acknowledge that I am not an employee of the promoter, organizers, or sponsors of the event.

I AGREE TO EXPRESSLY ASSUME ALL RISKS OF INJURY OR DEATH that might be associated with this land speed record attempt. Furthermore, to the fullest extent allowed by law, **I AGREE NEVER TO SUE AND TO RELEASE FROM LIABILITY THE PROMOTER, ITS AGENTS, SPONSORS, SANCTIONING BODIES, AND AFFILIATED PERSONAL** for any damage, injury, or death to me arising from participation in the land speed attempt, regardless of cause, including **NEGLIGENCE**.

I UNDERSTAND THIS IS A RELEASE OF LIABILITY THAT IS VALID FOREVER. I understand that this **RELEASE OF LIABILITY** will prevent me or my heirs from filing suit or making any claim for damages in the event of injury or death to me arising out of participation in the land speed record attempt. Additionally, in the event I, my heirs, the user, my legal representative, or any other person acting on my behalf files a lawsuit arising out of my participation in the event or use of the facilities, **I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS THE PROMOTER, ITS AGENTS, SPONSORS AND AFFILIATED PERSONAL** for any damages, attorneys' fees, or costs associated with or arising out of such a lawsuit.

With a complete understanding of this **RELEASE OF LIABILITY AND EXPRESS ASSUMPTION OF RISK AGREEMENT**, I nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon me, my heirs, assigns, legal representative, and any other person acting on my behalf. I grant exclusive permission to the promoter to use my name, likeness, and photograph for the purpose of publicity, public relations, editorial, or other advertising purposes without restriction as to frequency or duration. I agree that any legal action will be brought in a court of competent jurisdiction in the country of Bolivia. Any disputes will be subject to and determined under the laws of Bolivia.
