1. Introduction

VoLo Earth Ventures (“Company”, “we”, “our”, or “us”), based in Colorado, is committed to protecting your privacy. 2. Information We Collect

We collect limited personal information:

3. How We Use Your Information

4. Legal Basis for Processing (GDPR)

5. Your Rights

Under CPA (Colorado) and CCPA/CPRA (California):
