Further to nursing qualifications and experience I have undertaken medico legal training and am aware of my responsibilities as an expert witness under the Civil Procedure Rules. I have experience in liaising with the legal team and understanding of the medico-legal litigation process. I have participated within numerous case conferences with Counsel, expert meetings,
