Over these 8 years I developed knowledge of frailty, pressure area care, risk assessments, falls assessments and monitoring of acutely unwell patients.

It was here working within primary care but also alongside A&E developing admission avoidance pathways that I found my passion and went onto complete modules at master's level to become an ANP and went onto training and mentoring other Advanced care practitioners. After 6 years I moved into working within GP surgeries, where I am still currently employed.
