I believe the board should remain united and consistent so the club can continue to run smoothly and efficiently.

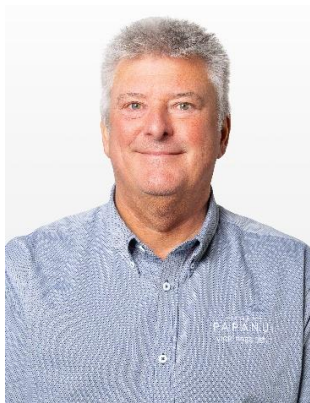
