10. STORAGE AGREEMENT TERMS & CONDITIONS

By signing this Agreement, you agree to the following terms and conditions governing the storage of precious metals by Tara Gold and Silver Limited (trading as Tara Coins).

10.1 Ownership & Bailment

All precious metals deposited by the Customer are held by Tara Gold and Silver Limited on bailment. The Customer retains full legal and beneficial ownership of their metals at all times. Metals are not assets of Tara Gold and Silver Limited and are held entirely outside the banking and financial system. In the event of insolvency of Tara Gold and Silver Limited or the vault operator, the Customer's metals cannot be claimed by creditors and will be returned to the Customer.

10.2 Segregation & Allocation

All metals are fully segregated and individually allocated in the Customer's name. Metals are never pooled, commingled, leased, or rehypothecated. Each item is recorded by description, quantity, serial number (where applicable), weight, and fineness.

10.3 Insurance

All metals in storage are comprehensively insured against theft, loss, and damage. Insurance is provided by leading international insurers including Lloyd's of London.

10.4 Storage Fees

Storage fees are calculated daily based on the market value of the Customer's holdings (using the LBMA PM Fix) and billed quarterly in arrears. Current fee rates are set out in the Fee Schedule (Section 11). Tara Gold and Silver Limited reserves the right to amend the fee schedule upon thirty (30) days' written notice.

10.5 Lien

Tara Gold and Silver Limited reserves a lien over metals in storage for any outstanding fees or amounts owed. In the event that fees remain unpaid for more than ninety (90) days after written notice, Tara Gold and Silver Limited may sell sufficient metals to recover outstanding amounts. The Customer will be given thirty (30) days' written notice before any such action is taken.

10.6 Limitation of Liability

Tara Gold and Silver Limited's liability in respect of stored metals shall not exceed the market value of the metals at the time any loss is discovered. Tara Gold and Silver Limited shall not be liable for any indirect or consequential loss. This limitation does not apply where loss arises from fraud or wilful misconduct.

10.7 Delivery & Collection

The Customer may request delivery or collection of their metals at any time by providing written notice. Delivery shall be arranged at the Customer's cost, fully insured. Collection may be arranged by appointment at the vault location, subject to the vault operator's security protocols.

10.8 Termination

Either party may terminate this Agreement by giving thirty (30) days' written notice. Upon termination, the Customer shall arrange for the collection or delivery of their metals and settle all outstanding fees. If metals are not collected within sixty (60) days of termination, Tara Gold and Silver Limited may arrange storage at the Customer's cost.

10.9 Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Ireland. The parties submit to the exclusive jurisdiction of the Irish courts.

10.10 Data Protection

Tara Gold and Silver Limited will process your personal data in accordance with the General Data Protection Regulation (GDPR) and our Privacy Policy, available at <https://www.taracoins.com/privacy-policy>. Your data will be used for account administration, regulatory compliance, and communication regarding your storage account.

11. FEE SCHEDULE

Fees are calculated daily based on the market value of your holdings (LBMA PM Fix) and billed quarterly in arrears. Minimum storage value: **€40,000 / \$50,000**.

12. COOLING-OFF PERIOD

Right of Cancellation: You have the right to cancel this Storage Agreement within fifteen (15) calendar days of the date your account is confirmed as open. To exercise this right, notify Tara Gold and Silver Limited in writing by email to info@taracoins.com or by post. If you cancel within the Cooling-Off Period, any metals already deposited will be returned to you or sold at your instruction, and any storage fees paid will be refunded in full. Standard transaction fees apply to any trades executed during this period. After the Cooling-Off Period, the Agreement continues subject to the termination provisions in Section 10.8.

13. DECLARATIONS & ACKNOWLEDGEMENTS
