collect	Sends data to Google Analytics about the visitor's device and behavior. Tracks users across devices and marketing channels.
Product cookies (e.g., same as website name)	Includes SSO-related and local storage-related cookies for efficient product usage.

How to Control Cookies

You can control and/or delete cookies as you wish:

- You can delete all cookies already stored on your computer.
- You can set most browsers to prevent cookies from being placed.

However, doing so may require you to manually adjust some preferences every time you visit the site, and some services or functionalities may not work properly.

You may also choose to:

- Set your browser to warn you about cookie placement.
- Limit the types of cookies you allow.
- Refuse cookies altogether (with possible impact on site functionality).
