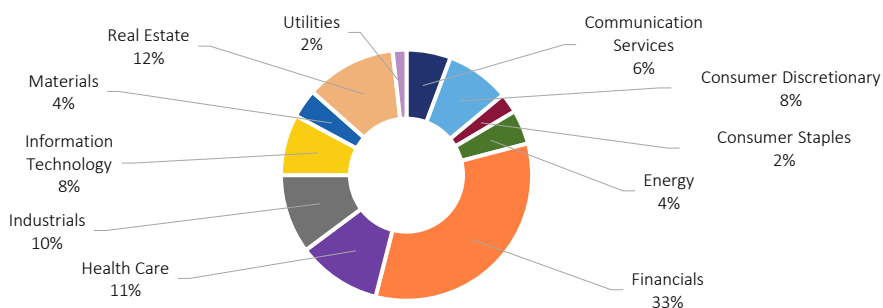


Brandywine US Micro-Cap Value IndexSM

The Brandywine US Micro-Cap Value IndexSM, designed by Brandywine Global Investment Management, LLC, measures the performance of the microcap value companies in the Wilshire 5000 Total Market IndexSM (Wilshire 5000SM). The Brandywine US Micro-Cap Value Index was released September 2019 with a time series of data beginning on September 28, 2012.

Sector Classifications (% Weights)



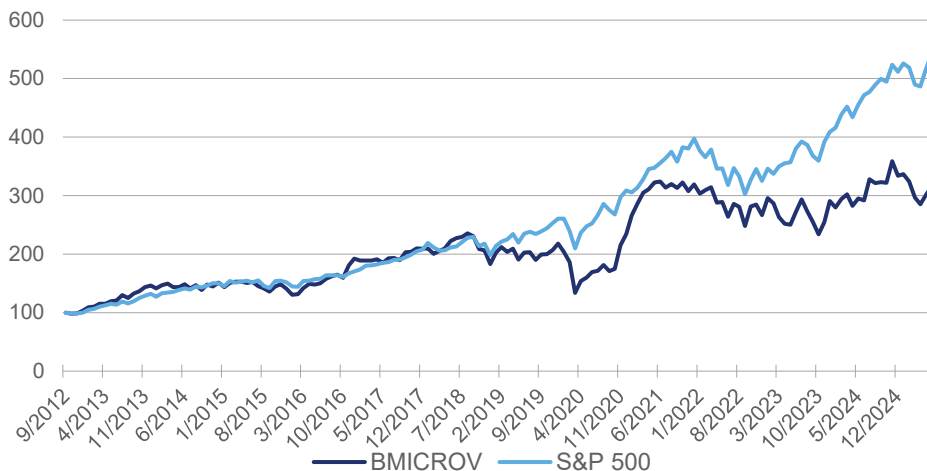

Objective

To benchmark the value component of the micro-sized US market.

Key Features

- The index is a subset of the Wilshire 5000 Total Market Index.
- Stocks selected from the bottom 1,750 companies by size in the Wilshire 5000.
- Includes the 750 most value companies by Wilshire Style score
- Only the 12.5 percent of the most value scored stocks in the resulting Drugs & Medicine industry are eligible for inclusion.
- Exclusions include tracking stocks and ADRs.
- Bulletin-board and thinly traded issues are excluded generally because they do not have readily available prices.
- Weighted by float-adjusted market capitalization.
