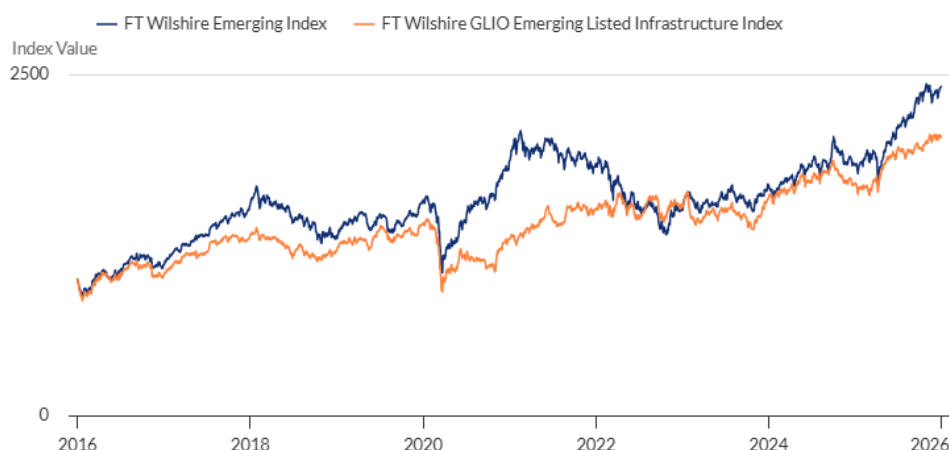
FT Wilshire GLIO Emerging Listed Infrastructure Index

The FT Wilshire GLIO Emerging Listed Infrastructure Index provides exposure to globally listed companies which own and/or are operators of infrastructure assets.

The index uses a systematic approach to identify eligible infrastructure companies through the use of EBITDA and mapping Global Asset Taxonomy System (GATS) to common Infrastructure Sectors.
