## Selection Criteria

Seed Fund applications will be assessed on the following selection criteria:

-  Excellence and creativity of the proposed research project (25%)
-  Alignment with TCA's research priorities (25%)
-  Potential for the project to create broader commercial, research, policy, or social relevance opportunities related to the ocean and climate change (25%)
-  The project's plan to foster and support respectful engagement, the removal of systemic barriers, and equitable access considerations (25%)

**Note:** The fund cannot be used to supplement OFI's large research projects currently underway.
